#### **Notice for Invitation**

PMU-OHEPEE, Higher Education Department, Government of Odisha invites bids from reputed interested & eligible hotels/ lodgings/ hospitality agencies located within Bhubaneswar Municipality Corporation for accommodation facility for various residential training programs going to be conducted by PMU-OHEPEE during next 3 (Three) years.

Interested bidders may obtain details terms & conditions for taking up this assignment by downloading the tender document from Government of Odisha, Higher Education Department's website i.e. <a href="www.dheodisha.gov.in">www.dheodisha.gov.in</a> and submit their expression in sealed document as per the instructions mentioned in this Eol document.

#### **Eligibility Criteria for the Interested Firm**

The interested firm should meet the following criteria;

- 1) Must have a valid PAN
- 2) Must have a valid GST registration number
- 3) Must be a legal entity i.e either registered under Indian Companies Act or Indian Partnership Act or Proprietorship firm act
- 4) Should have Trade & Health license from Bhubaneswar Municipal Corporation
- 5) Should have Fire Safety Certificate
- 6) Should not have been blacklisted by any State Government/ / Central Govt / PSU in India .A self-declaration is required.
- 7) Minimum fifteen (15) numbers of twin sharing AC rooms shall exist in a single premise

#### **General Terms & Conditions of Tender**

**Note:** Bidders must read these conditions carefully and comply strictly while submitting their bids.

- a) The accommodation will be for Air Conditioned rooms with attached bathroom on twin sharing basis. Accommodation of bidders with all valid documents will be inspected by the tendering authority and if facility is found satisfactory, empanelment will be carried out which will be valid for two years.
- b) Minimum fifteen (15) numbers of rooms shall exist in a single premise for applying under this tender. Once empanelled, the rooms will be booked as per the requirements and as per availability for the required dates with the agency / hotel.
- c) Bill for 1 day occupancy will be considered from 12 noon to 12 noon.
- d) The per day rent of the twin sharing A/C rooms will be Rs 1,500/- (Rupees Fifteen Hundred only) inclusive of all applicable taxes
- e) Tenderer will pay only the accommodation charges i.e Rs 1,500/- (Rupees Fifteen Hundred only) inclusive of all applicable taxes per day for twin sharing A/C rooms. The invoice should be raised to the "State Project Director, OHEPEE, Higher Education Department, Government of Odisha".
- f) For Serving of Foods & beverages to the guests, the invoice should be directly raised to the guest and the amount should be collected from them.
- g) EoI not submitted in prescribed format or in prescribed manner, shall be rejected.
- h) Each page of the EoI document should be signed by the bidder with seal, in token of having understood and accepted the terms and conditions of the contract and serially numbered and page marked.
- i) The bidder or authorized representative (one person only) will be allowed to be present at the time of pre bid meeting.
- j) A telephonic discussion will be held with the contact person of the hotel/ agency at least 4 days prior to reservation to know the availability of rooms. Accordingly to availability, the list / number of guests will be sent by email ( from <a href="mailto:pmuohepee@gmail.com">pmuohepee@gmail.com</a> to the email id provided in sl.no.3 of 'Submission of Interest') on the next day with number of occupancy days required. Confirmation emails have to be sent within 12 hours of receiving of the details.
- k) Payments will be made within 30 days of submission of invoice with details of guest attendance.
- I) Any notice given by one party to the other pursuant to this contract shall be sent in writing.
- m) All the disputes shall be subjected to the jurisdiction of Khurda district.

#### **Evaluation & Award of Contract**

- I. PMU, OHEPEE will examine & determine whether each bid is of acceptable quality, is generally complete & is substantially responsive to the bidding documents.
  - a. A substantially responsive bid is one that conforms to all the terms, conditions and specifications of the bidding documents without material deviations, objections, conditionally or reservation.
  - b. In case of tenders containing any conditions or deviations or reservations about contents of tender document, the tender shall be treated as non-responsive.
  - c. Decision of the tender inviting authority regarding responsiveness or non-responsiveness of a tender shall be final and binding.
- II. PMU, OHEPEE will issue LoA (Letter of Award) to the successful bidder by a Registered /Speed Post or by bearer. Duly signed and stamped duplicate copy of LoA has to be returned by the successful bidder within 7 (Seven) working days of receipt of LoA as token of acknowledgement. Accepting the LoI will be treated as an agreement between the bidder(s) and the PMU. No separate agreement will be signed.
- III. On requirement basis work order will be issued.
