

2) Terms of reference of the Committee will be as follows:

1. To scrutinise the applications and study the feasibility of upgradation of the existing technical engineering/professional institution of the State to the status of the university strictly as per the guideline for establishment of private universities in the State of Odisha issued vide Notification No. 20264/HE dt 8.8.2012 .

2. To decide objective parameters for evaluation of the proposals, which may include but not limited to (i) Adequacy of land held by the educational institution
- (ii) Deposit of corpus fund
 - (iii) Accreditation by NBA/NAAC
 - (iv) Track record of the work done by the educational institution in KBK/ KBK plus districts of the State and
 - (v) Record of timely disbursement of salaries to teaching and non-teaching staff.
- 3) The Committee shall meet at least once in each quarter.
- 4) The Committee may take appropriate decisions on the manner of obtaining data, including on-line submission of documents and field inspection as may be required.
