
No.HE-FE-IV(A)-POL-0042/2014 14554 /HE, In exercise of the powers conferred by sub-section (4) of Section 7-C of the Orissa Education Act, 1969 (Orissa Act 15 of 1969), the State Government have been pleased to make the following order to amend the Odisha (Non- Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-Aid Order, 2008 namely:-

1. (1) This order may be called the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-Aid (Amendment) Order, 2016.
- (2) It shall be deemed to have been come into force with effect from the 1st October, 2016.

2. In the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-Aid Order, 2008, in the proviso to para-1(v) of Annexure-II, after the words " computing the workload in that subject for that year", the following words shall be inserted, namely:-

" for the purpose of Educational Institutions not being a Women's College and situated in a district other than Educationally Backward District".
