Sub: Approval of the posts of the Non-Government Colleges, Junior Colleges and Higher Secondary Schools of Odisha.

Sir,

In inviting a reference to the subject cited above, I am directed say that as per the discussion in the meeting held on 18.02.2018 with the delegates of the Lecturers and Teachers Association of Non-Government Colleges, Junior Colleges and Higher Secondary Schools of Odisha in presence of Hon'ble Minister, School & Mass Education, Odisha and Hon'ble Minister, Higher Education, Odisha it was decided to accept all appointments through Wall Notices as the newspapers were not commonly accepted during the early 1990's when such employees joined the services of aided colleges. Besides, similarly situated staff of the Non-Government Colleges, Junior Colleges and Higher Secondary Schools of Odisha have been extended grant-in-aid earlier.

Keeping in view of the above aspects, it has been decided to accept all such appointments (teaching & non-teaching) made by the college authorities of Non-Government Colleges, Junior Colleges and Higher Secondary Schools of Odisha for extending grant-in-aid as per Grant in Aid Order, 2014.

However, the governing bodies shall be requested to scrupulously follow the rules and procedures as per Government guidelines issued from time to time to avoid future litigation.

You are, requested to take necessary action accordingly.
