Sub: Student Academic Management System – Student slide-up regarding

Madam/Sir,

With reference to the subject cited, I am directed to say that the following guidelines have been finalized to deal with the slide-up case for the Academic Session 2016-17 for junior colleges in the Technical Sub-Committee meeting on e-Admission held on 13-07-2016 at 11.00 A.M.

- 1) (a) Students slide-up to higher option but not taken CLC will be adjusted in the college where s/he has taken admission in first / second selection of e-Admission (Phase-I) for the session 2016-17 only.
(b) Students who were slide-up to higher option, CLC issued by college but could not take admission during the scheduled admission period, will be allowed to take admission against the vacant seats subject to availability of seats or against the additional seats created for them, in the colleges, from where they had been issued CLC during Admission (Phase-I) for the session 2016-17.
- 2) Students coming under categories 1 (a) & (b) will not be out of the system during the admission process.
- 3) The number of students coming under 1 (a) & (b) of respective colleges will be adjusted against the existing vacancies before the 2nd phase of admission, if not, then the required number of seats may be created to accommodate the above category of students only for the session 2016-17. No admission on transfer basis from one college to another college in a particular college/stream can be made against the seats created under the above circumstances.
- 4) A MIS report has been developed on the above principle & placed in the website (<http://dheodisha.gov.in/SAMS>) namely "Vacant Seats of e-Admission Phase-II" shall be followed.
- 5) Transfer cases from one college to another college will be made on the basis of actual sanctioned strength. Actual sanction strength doesn't include seats created under special circumstances above.
