Eligibility:



The applicants who have passed the Supplementary/Instant examination conducted CHSE (O) or could not apply during the normal application period due to various reasons

- The applicants who have not got a seat during Phase-I, Phase-II, Phase-III online admission.
- The applicants who are selected but could not take admission due to various reasons.
- The applicants who have already taken admission in normal admission period but want to switch over to other colleges.

Procedure:

- 1. An interested candidate can apply online or download the offline CAF from the website www.dheodisha.gov.in
- 2. Then submit the filled CAF with relevant documents at the nearest SAMS Resource Center.
- Merit list will be prepared centrally through SAMS Application & available in Website & College e-Space.
- 4. Transfer admission (This Department Letter No: 26563/ Dated: 20-09-2016) is stopped in Degree & Autonomous Colleges from 2nd Oct 2016 onwards until further order.
- 5. Refund of admission fees is also applicable in this phase of admission. However, this department shall not entertain any complain in this regard.
- 6. Colleges are requested to admit the selected candidates with an undertaking to deposit the CLC/ Migration Certificate within 22nd Oct, 2016 at 3:00pm. No further request of updation of admission data will be entertained further after the due date.
- 7. For +3 Degree/ Autonomous colleges, three scenarios are expected and accordingly three different examples have been cited below.

Scenario: 7.1

In an Autonomous colleges, if there are three Honours subjects in Physics Science (PCM) stream i.e. Physics, Chemistry & Mathematics with a sanctioned strength of 128 then the total no. of additional seats to be created will be 13. And the additional 13 Honours seats shall be distributed among all admitted students of the current session as per the merit. No other equation will be followed in this context.

Scenario: 7.2

In a +3 Degree Colleges, if there are multiple subjects in commerce stream i.e Accounting, Finance, Marketing, Auditing, Business Mathematics & Management with a sanctioned strength of 384 and different intake capacity against each individual subject then the number of additional seats to be created will be 38 and distributed proportionately among both Honours & Pass subjects. No other equation will be followed in this regards.

Scenario: 7.3

In a +3 Degree Colleges, if there is no Honours subject in particular streams then the additional seats to be created will be 10% of the sanctioned strength in all pass subjects. No other equation will be followed in this context.
