**NOTIFICATION**

Bhubaneswar, dated the 29<sup>th</sup> October, 2013

No..HE-FE-II(A)POL.12/2013      26782      /HE. In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Education Service (College Branch) Recruitment Rules, 1990, namely;-

1. (1) These rules may be called the Odisha Education Service (College Branch) Recruitment Amendment Rules, 2013.  
(2) They shall come into force on the date of their publication in the Odisha Gazette.
  
2. In the Odisha Education Service (College Branch) Recruitment Rules, 1990 (hereinafter referred to as the said rules) in rule 4, in sub-rule(2),-
  - i In clause(e), in sub-clause (i) and (ii) of Rule 4(2), the following provision shall be substituted, namely:-

"4(2)(e) NET shall remain the compulsory requirement for appointment as Lecturer for those with postgraduate degree, but the candidates having Ph.D. Degree on the concerned subject shall be eligible and exempted from the requirement of NET/SLET/SET".
  
3. In the said rules, in rule 5, for sub-rule (1), the following sub-rule shall be substituted, namely:-

"5. Selection by the Commission, - (1) The vacancies in the post of Lecturer occurring in a year shall be notified to the Commission by the Government. The Commission shall invite applications through open advertisement from eligible candidates and after conducting interview


forward to the Government in respect of each subject a list of suitable candidates in order of merit for which requisition has been made. The selection of eligible candidates shall be made on the basis of merit”.

4. In the said rules, for rule 6, the following rule shall be substituted, namely:-

“6. Reservations- Notwithstanding anything contained in these rules reservation of vacancies or posts, as the case may be made, for-

- (a) Scheduled Castes and Scheduled Tribes shall be made in accordance with the provisions of the Odisha Reservation of Vacancies in Posts and Services (for Scheduled Castes and Scheduled Tribes) Act, 1975 and the rules made there under; and
- (b) SEBC, women, sports persons, Ex-servicemen and Persons with Disabilities shall be made in accordance with the provisions made under such Act, rules, orders or instructions issued in this behalf by the Government from time to time.”
