**S. R. O. No. 438/2006**—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Orissa is pleased to make the following rules further to amend the Orissa Education Service (Professor's Grade) Recruitment Rules, 1990, namely :—

1. (1) These rules may be called the Orissa Education Service (Professor's Grade) Recruitment Amendment Rules, 2006.

(2) They shall come into force on the date of their publication in the *Orissa Gazette*.

2. In the Orissa Education Service (Professor's Grade) Recruitment Rules, 1990 (hereinafter referred to as the said rules) in rule 5 (i) for sub-rule (i), the following sub-rules shall be substituted, namely:—

“(i) The post of Professor in the Service shall be filled up by selection through the Commission from among the eligible Readers in Government Colleges of Orissa on merit and suitability with due regard to seniority”.

(ii) After item (a) to the 3rd proviso, the following item shall be inserted, namely:—

“(aa) For Graduation Degree with Distinction ‘two’ marks will be awarded irrespective of a candidate passing with or without Honours”.

3. In the said rules, after Rule 6, the following rules shall be inserted, namely:—

“6-A. Forwarding of documents to Commission— For preparation of the select list, the following documents shall be forwarded by the Government to the Commission:—

(a) Records of all eligible Officers as per U. G. C., eligibility norms and qualification

(b) Gradation list of Officers

(c) C. C. Rs. of the Officers for consideration by the Commission

(d) Indication about the pending representation against adverse remarks in

C. C. Rs., if any; and



- (e) Status of Disciplinary Proceedings and Vigilance Proceedings, if any.
- (f) Any other documents as deemed proper to the purpose, like,—
- (i) Attested statement indicating the performance of the eligible Readers at various levels like Matriculation, Intermediate, Degree, Honours, Distinction as provided in Schedule 'A' to the University First Statutes, 1990.
- (ii) Copies of publications in National/International Journals only".

6-B. Selection by the Commission—(1) The Commission shall consider the case of all eligible Officers coming under U.G.C., eligibility norms and qualifications and prepare a list of such Officers in order of merit as are found by them suitable for appointment.

(2) The vacancies in different disciplines including those anticipated during the year shall be notified/intimated to the Commission by the Government.

4. In the said rules, in rule 7, for sub-rule (i), the following sub-rule shall be substituted, namely :—

"(i) On receipt of the requisition from Government, the Commission shall conduct interview for the purpose and prepare a list of Officers found suitable by them for appointment as Professor :

Provided that the select list shall be 1.25 time of the vacancies"; and

(ii) the "Note" appearing after sub-rule (5) shall be deleted.
