NOTIFICATION

S. R. O. No. 435/2006— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Orissa is pleased to make the following Rules further to amend the Orissa Education Service (Senior Administrative Grade) Recruitment Rules, 1990, namely :—

1.(1) These rules may be called the Orissa Education Service (Senior Administrative Grade) Recruitment Amendment Rules, 2006.

(2) They shall come into force on the date of publication in the *Orissa Gazette*.

2. In the Orissa Education Service (Senior Administrative Grade) Recruitment Rules, 1990 (hereinafter referred to as the said rules) in Rule 4 ;

(i) for sub-rule (1), the following sub-rule shall be substituted, namely :—

“(1) (a) Recruitment to the posts of Principal Grade-I (Professors Grade) shall be made by selection by the Commission from among the eligible Principals (Readers Grade) and Professors in the Government Colleges.

(b) Recruitment to the post of Principal (Readers Grade) shall be made by selection by the Commission from among the eligible Readers in Government Colleges”;
and

(ii) In Rule 5, in sub-rule (3) for the word “Promotion” the word “Selection” shall be substituted ;

3. In the said rules, for Rule 5, the following rule shall be substituted, namely :—

“5. Selection by the Commission—

“(1) (a) The Commission shall consider the case of all eligible Officers coming within the Zone of consideration as defined in the Orissa Civil Services (Zone of Consideration) Rules, 1988 and prepare a list of such officers in order of merit as are found suitable for appointment. For the purpose of selection the Commission shall conduct an interview of the eligible Officers.

- (b) The vacancies including those anticipated in the course of that year shall be notified/intimated to the Commission by the Government.
- (2) The number of Officers to be included in the list shall be 1.25 times the number of vacancies arrived at under sub-rule (1)".
4. In the said rules, for Rule 6, the following rule shall be substituted, namely :—
- "6. Forwarding of Documents to the Commission—Document to be forwarded to the Commission for preparation of the Select List, the following documents shall be forwarded by the Government to the Commission for preparation of the Select List—
- (a) Records of all eligible Officers included in the list as per the provisions of the Orissa Civil Services (Zone of Consideration) Rules, 1988,
- (b) Gradation List of Officers,
- (c) C.C. Rs. of the Officers for consideration by the Commission,
- (d) Indication about the pending representation against adverse remarks in C. C. Rs., if any, and
- (e) Status of the disciplinary proceedings/vigilance proceedings, if any".
5. In the said rules, after Rule 6, the following rule shall be inserted, namely :—
- "6-A. Recommendation of the Commission—The Commission after preparing the Select List of the suitable Officers shall convey its recommendation to the Government".
6. In the said rules, for Rule 7, the following rule shall be substituted, namely :—
- "7. Select List—(1) The recommendation of the Commission shall be placed before Government and shall from the select list after its approval of the Government with or without modification, if any.
- (2) The select list shall ordinarily remain valid for a period of one year".
7. In the said Rules, for Rule 8, the following rule shall be substituted, namely :—
- "8. Seniority—Appointment to the post of Principal (Professors Grade) and Principal (Readers Grade) shall be made as per order in which the names appear in the Select List and the *inter se* seniority of the Officers so appointed to the respective Grades shall be maintained in that order".
8. In the said rules, in Rule 9, for sub-rule (1), the following sub-rule shall be substituted, namely :—
- "1. Appointment to the Post of Director of Higher Education shall be made by way of Selection from among the Principals (Professors Grade) who have officiated in that Grade for a period of not less than two years including actual experience as Principal (Professors Grade) for a period of not less than one year".

9. In the said rules, for Rule 10, the following rule shall be substituted, namely :—

"10. Departmental Promotion Board—(1) There shall be a Departmental Promotion Board (hereinafter referred to as the Board) to consider the eligible Principals (Professors Grade) for promotion to the post of Director, Higher Education consisting of the following Officials, namely :—

(2) The Board shall meet preferably on the 1st day of January of the year and prepare a list of such officers found suitable for promotion for the post of Director of Higher Education. The Board shall follow the provisions of Orissa Civil Services (Zone of Consideration for Promotion) Rules, 1988. The Orissa Civil Services (Criteria for Promotion) Rules, 1992. Instruction on Sealed Cover procedure issued by the General Administration Department from time to time and Orissa Civil Services (Criteria for Selection for appointment including Promotion) Rules, 2003".

10. In the said rules, for Rule 12, the following rule shall be substituted, namely :—

"12. Select List—The list prepared by the Board shall be referred to the Commission for their concurrence. On receipt of the recommendation of the Commission, the list shall be submitted before the Government for approval and after approval by the Government, shall form the Select List.

(2) The Select List shall ordinarily remain valid for a period of one year.
