**TERMS & CONDITIONS:**

1. The services of the said Consultants and Senior Consultants are placed at the disposal of Odisha State Higher Education Council, Bhubaneswar.
2. Their engagements are made on contractual basis and purely temporary, subject to authentication of all credentials by concerned institutions and employees.
3. No travelling allowance is allowed to join their place of engagement.
4.
  - (i) The engagement is purely on contract basis for the specific period of 05(five) years or till the completion of the project with an initial probation period of 06(six) months. A performance appraisal at the end of six months will determine extension of contract.
  - (ii) An annual performance appraisal mechanism will be set in place, which will determine the continuation of the term till the end of the project. However on unsatisfactory performance, candidate can be disengaged with a 15 days' notice. In case candidate wishes to leave job for any reasons, one month notice is mandatory.

- (iii) Refusal/ unauthorised delay to accept the engagement will be treated as cancellation of engagement and the candidate shall be deemed to have forfeited his claims for future engagement as Consultant in the Higher Education Department.
