**Sub: Special Slide-up case admission in Degree (+3) Colleges under the Project Student Academic Management System (SAMS).**

Madam/Sir,

With reference to the subject cited, I am directed to say that Govt. have been pleased to consider the slide up cases sympathetically and also provide another chance to the students to get admitted in the slide-up colleges:

1. Student who had slide up to higher option but not taken admission during the scheduled admission period, will be allowed to take admission in the higher preference college only where s/he has got selected. All the admissions relating to the slide-up matter shall be completed at the earliest. The CLC, generated along with the intimation letter will be valid for this purpose and colleges are requested to accept this. If no vacancies exist to accommodate slide up students, then it can be created over and above the sanctioned seats for this year only.
2. Principals will be personally held responsible in case any slide up students continues in the previous Colleges after CLC is generated. As last date for ROI (Return of Intermediate) submission at University may close in near future, students be advised to join in the higher preference College immediately.
3. In the offline mode, if the student was selected in the applied college to take admission on 14<sup>th</sup> October, 2017, but has not joined due to various reasons, it will be considered provided vacant seat exists for such admission.

Therefore, you are instructed to comply with the above directions without fail.
