Applications are invited from eligible candidates (academicians of repute with administrative experience) below 62 years of age (as on 1<sup>st</sup> October' 2020 i.e. born after 30.09.1958) for the position of Vice-Chancellor of North Odisha University, Baripada, Odisha for appointment by the Chancellor as per Section 6 of the Odisha Universities Act' 1989. The applicant should be a distinguished academician of proven academic and administrative excellence and a well rounded personality with a minimum of 10 years experience as Professor in a University system or 10 years in an equivalent position in reputed research and / or academic organization.

The post carries a pay of Rs. 2,10,000/- (Rupees two lakhs and ten thousand) with Special Allowance of Rs. 5000/- per month and other usual allowances. As per the Odisha Universities Act' 1989, the tenure of the Vice-Chancellor shall be three years from the date he/ she assumes office or till he/ she attains 65 years of age; whichever is earlier.

Shortlisted candidates shall be called for interview by a three-member Search Committee which will recommend three names to the Chancellor for appointment of one as Vice-Chancellor.




