Sub: Transfer of jurisdiction over grant of permission and recognition to Public Health and other Medical Education Related Courses

The Higher Education Department has been receiving applications/proposals from various Educational Agencies seeking permission and recognition under Orissa Education Act, 1969 for establishment of educational institution to impart courses in Public Health and some other Medical Education related subjects. Since this subject matter comes under the domain of Health and Family Welfare Department (H & FW), Government of Odisha; it is hereby decided that Permission and Recognition to such courses shall henceforth be granted by H& FW Department, Government of Odisha. All applications/proposals relating to these courses, currently pending in Higher Education Department, shall be transferred to H& FW Department for further necessary action at their level. The course curriculum, affiliation, conduct of examination, etc. shall, however, be dealt by the Universities concerned.


