**VICE CHANCELLOR OF RAJENDRA UNIVERSITY (BOLANGIR, ODISHA)**

Applications are invited from eligible candidates (academicians of repute with adequate administrative experience) below 63 years of age (as on 1<sup>st</sup> March 2021, i.e. born after 01.03.1958) for the position of Vice-Chancellor of Rajendra University\*, Bolangir, Odisha. The applicant should be a distinguished academician of proven academic and administrative excellence and a well-rounded personality with a minimum of 10 years of experience as Professor in a University system or 10 years in an equivalent position in reputed research and / or academic organization.

The post carries a pay of Rs. 2,10,000/- (Rupees two lakhs and ten thousand) with Special Allowance of Rs. 5000/- per month and other usual allowances. The tenure of the Vice-Chancellor will be four years from the date he/she assumes office or till he/she attains 67 years of age; whichever is earlier.

The applicants are required to apply in the prescribed application proforma through e-Mail attachment (only in pdf format) to our e-Mail ID ([hedsec.od@nic.in](mailto:hedsec.od@nic.in)) mentioning "Application for the post of Vice-Chancellor of Rajendra University" as the subject of the e-Mail. Shortlisted candidates will be called for interview (to be held in Bhubaneswar in physical mode) by a three-member Search Committee. After interview, the Committee will recommend three candidates to the Chancellor (i.e. The Hon'ble Governor of Odisha) who will select one of them for appointment as Vice-Chancellor.


