Principle for DBT of Cash in lieu of Laptop to 12<sup>th</sup> pass out  
meritorious students in the State under  
“Biju Yuva Sashaktikaran Yojana”- 2020-21**

Higher Education Department, Government of Odisha have been distributing free laptops to the 12<sup>th</sup> pass out meritorious students since last Six years i.e. since the year 2013.

**Since inception of the scheme the year wise decisions taken is reproduced below:**

• **Year - 2013:**

As per the decision taken by the Expenditure Finance Committee (EFC) in the meeting held on 28-May-2013 the merit list of CHSE, Odisha pass out students for the year will be taken into account to select the eligible students in the said scheme. It was decided to distribute the laptops as per the allotment as mentioned below:

The merit list would cover all the ST/SC students who had passed in 1<sup>st</sup> Division. After covering the 1<sup>st</sup> division students within the allotted numbers if any surplus number remains in the allotted quota in SC & ST category of students in the respective streams then it was to be further distributed on 50:50 ratio between the ST & SC students.

• **Year 2015 & 2016:**

During the year 2015 & 2016, the Government further decided to include the Vocational students passing from CHSE (O) and Upashastri students passing from Shree Jagannath Sanskrit University, Puri under this scheme. Hence, the revised allotment of laptops was as follows.

The above mentioned allotment continued till 2018.

- **Year 2019 :**

It was felt that there was lack of proportionate representation of meritorious students from the backward districts if laptops are distributed basing on State level pass percentage. As they failed to compete with the students of advanced districts/urban based colleges on merit, thus failed to avail laptops.

Therefore, for widespread representation, in the year 2019 it was decided to allot the laptops based on the district level pass percentage instead of state level pass percentage. Accordingly, the procedure for selection has been slightly changed.

**Formula adopted for stream wise selection of number of students in each district:**

No of students =  $\frac{\text{Students passed in Science Stream in the District} * \text{No. of laptops earmarked for Science Stream}}{\text{Total no. of Students passed in Science Stream in Odisha}}$

Total no. of Students passed in Science Stream in Odisha

The reservation for SC/ST has been followed such as: 16.25% and 22.50% respectively has been included while preparing the district wise merit list.

- **Method of selection of students for the year 2020:**

To make the stream wise, category wise allotment more accurate the allotment approved in the EFC meeting held on 28.05.2013 and decisions taken by Government in 2014 for the years 2015, 2016, 2017, 2018 and in 2019 for the year 2019 have been taken into consideration and the allotments have been made as mentioned below.

The total number of beneficiaries under General Category=10,000 and SC/ST category=5000. Therefore, there is a need to bifurcate 5000 students between SC & ST stream wise which has been done basing upon their reservation in the State, i.e., 22.5% for ST and 16.25% for SC, total =38.75%. Thus, the following formula has been adopted for the purpose.

***Total number allocated to SC and ST students in a particular stream/Percentage of reservation for SC and ST together \* Reservation% for SC or ST***

***For example: Total number allocated to SC and ST students together in Arts stream=2300***

***Number allocated for SC students=2300/38.75\*16.25= 964.51 rounded off to 965.***

**Stream and category wise allocation of number**

Now, with a view to be more student centric, the State Government have decided to make the system faster & transparent. Therefore, instead of distributing the Laptops physically under “**Biju Yuva Sashaktikaran Yojana**” it has been decided to convert the distribution scheme to a Direct Benefit Transfer (DBT) scheme with effect from the financial year 2020-21, whereby Rs 30,000/- will be transferred to the bank account of beneficiary student directly. This will give flexibility and ample opportunity to a student to use the money transferred to his/her account in different possible ways helpful to him/her. He/she can even add his/her own money and can go for a high end laptop/desktop/tablet which can keep him/her abreast of the changing world.

Further, the stream wise and category wise pass out number of students have been collected from CHSE (O). For better transparency, the students have been selected basing on the respective district’s success/passing percentage of students category wise.

The formula for district wise allocation is:

***District wise allocation for a particular stream = {Total pass of the district (category)/ Total pass of state (category/ stream)} \* No of laptops/beneficiaries allocated for that (stream/ category)***

For example:

While, meeting the targeted calculated no. of a particular stream/category of a particular district, it has been observed that same mark has been scored by 5-10 students. Hence the previous highest mark has been considered.

Since inception, it has been observed that after publication of the list of cut-off marks for 15000 students, some students generally approach this department after re-addition of marks / caste change in the 12<sup>th</sup> mark sheet. Accordingly, looking at the number of balance laptops, this department used to publish the supplementary list for those students to get laptops. But, from this year onwards, as the fund will be directly credited to the student's account, there is no scope for publishing additional number of allocation beyond 15000. So, the primary list of 14,919 students have been prepared and 81 nos of allocation has been kept as reserve for those students who might apply after re-addition of marks /change of marks in the 12<sup>th</sup> mark sheets. In case nobody/less claim comes to this department, the remaining fund may be transferred to the students awaiting in the primary/ initial list.

**Instruction to beneficiaries to avail DBT facility:-**

- i. The meritorious students who pass 12<sup>th</sup> level from CHSE, Odisha, would be eligible to receive Rs.30,000/- (Rupees thirty thousand) only in lieu of laptop under the Scheme. The vocational students passing from CHSE (O) and Upashastri students passing from Shri Jagannath Sanskrit Vishwavidyalaya, Puri are also eligible to get the same benefits. The selection of students under the scheme would be taken from 12<sup>th</sup> results conducted by CHSE, Odisha on the basis of merit under each category.

- ii. Merit list of 15,000 students for this purpose shall be drawn from annual Higher Secondary examination passed students on the basis of the pass percentage of a district.
- iii. Budget provision of Rs.45 Crs (15000 \* Rs 30,000/-) shall be made for the said purpose through state plan scheme.
- iv. An online module by integrating the SAMS database has been developed so as to facilitate smooth implementation of the scheme for transfer of funds to the student's bank account directly. The selected meritorious students are required to upload their details in the DBT module link given in this Department's website i.e.- [www.dhe.odisha.gov.in](http://www.dhe.odisha.gov.in) by 18<sup>th</sup> March 2021.
- v. Soon after the entries of details of the students through the link, the same will be auto validated with the beneficiary's mobile number. Then the valid list will be published.
- vi. While filling up the details in the online application, in case of any difficulty the students may email to [laptopdbthelpdesk@gmail.com](mailto:laptopdbthelpdesk@gmail.com) or call on 0674-2954600. If the student wants to change the mobile number in the SAMS database to fill up the online application form, the student will have to send the self attested copy of Aadhaar card and duly filled in form as mentioned in **Annexure-A** by e-mail to [laptopdbthelpdesk@gmail.com](mailto:laptopdbthelpdesk@gmail.com). The same will be updated within one (01) working day.
- vii. Last date of uploading the beneficiary details in link given at Department website is 18-March-2021. Claim beyond the last date would not be entertained.
- viii. Soon after publication of select list of candidates, students who have any grievance (regarding caste change, mark re-addition, etc.) shall place the same before the concerned Principals. On consideration, if the grievance is found to be genuine, the Principals may request to the Department to include the name of such students in the supplementary list, provided there is surplus allotment.
- ix. A supplementary list of students will be published immediately after 24-March-2021 to cover for the number of eligible students under supplementary category. This list will also include the names of such students whose grievance are to be redressed. The last date for the selected students of supplementary list for uploading their details in the website is 30-March-2021.
- x. The selected students will have to open the Bank account in their own name if already no account exist in his/her name. But the KYC has to be updated in all accounts either old or new. Accounts such as:- Jaan Dhaan account/ Krushak Kalyan account where the KYC is not updated and the limitations of fund transfer is Rs.10,000/- will not be entertained under the Scheme.

- Visit the website [www.samsodisha.gov.in](http://www.samsodisha.gov.in) and click on “**Degree (+3)**” under “**Higher Education**”. Then, Click on “**Laptop DBT Scheme**”
- To login SAMS Portal Use your mobile number and password (Registered and created login during the academic session 2018-19).
- After successful login, eligible applicant (as per the list available under the link: <https://samsodisha.gov.in/Degreeweb.aspx>) can view their required details and also required to provide following details for further process:
  - i. Aadhaar Number
  - ii. Upload the legible scan copy of Aadhaar Card
  - iii. Applicant’s Name as mention in Bank Passbook
  - iv. Applicant’s Bank Account number
  - v. IFSC Code
  - vi. Bank Address
  - vii. Upload the legible Bank Passbook front page
  - viii. Mobile number of Applicant where OTP will be sent
  - ix. e-Mail ID of Applicant where OTP will sent
