In supersession of this Department Notification No.11494 dated 04.03.2020 and Notification No.18940 dated 11.06.2020, the State Government do hereby alter the territorial jurisdiction of all the existing Universities of the State and establish a new University called "Madhusudan Law University" at Cuttack by upgrading Madhusudan Law College, Cuttack with effect from the 28th April, 2021. All the existing Government and Private Law Colleges, except the constituent Law Colleges of different Universities of the State, shall cease to be affiliated from their respective University from 28th April, 2021 and shall stand affiliated to the Madhusudan Law University from that date. The said Madhusudan Law University shall have jurisdiction, save as aforesaid, over all Law Colleges of the State.


