PROCEEDINGS OF THE MEETING OF HIGH POWER COMMITTEE HELD ON 09.04.2021 AT 3.00 P.M. UNDER THE CHAIRMANSHIP OF PRINCIPAL SECRETARY TO GOVERNMENT, DEPARTMENT OF HIGHER EDUCATION.

A virtual meeting of the High Power Committee was held on 09.04.2021 at 3.00 P.M. under the chairmanship of Principal Secretary to Government, Department of Higher Education for consideration of the proposals regarding grant of permission/recognition in respect of Non-Government Colleges/Institutions under Section 5 and 6 of Orissa Education Act, 1969.

The list of members who attended the meeting through virtual mode is annexed at **Annexure-A**.

After welcoming the participants the Principal Secretary-cum-Chairman of HPC initiated the agenda wise discussion and invited them to offer their considered views on each agenda point.

At the outset, the Chairman apprised the newly inducted members about the decision taken in the last HPC held on 11.12.2019. In the said meeting in-principle decision was taken not to grant opening permission to any new Degree/ Professional College for a period of 05 years from the academic year 2020-21 to 2025-26 in order to prevent mushrooming growth of private colleges without required infrastructure and faculty. However, if the Educational Agency is a nationally or internationally acclaimed provider of Higher Education then that case can be considered. The Chairman highlighted that; the Student Academic Management System (SAMS) data of the last 5 years indicates a consistent decline in the percentage of admission against total allotted seat strength. It was 91.24% in the Academic year 2016-17, which has now come down to 67.78% in the Academic year 2020-21. The Committee agreed to the fact that there is a need to put more emphasis on quality of education over quantity of education/colleges and therefore, decided to stick to the earlier decisions taken in the HPC meeting held on 11.12.2019 to ensure the quality of education and stop increasing commercialization of higher education.

Accordingly, the Committee took the following decisions on the proposals/applications presented before it.

The agenda item-wise decisions taken in the meeting are given below.

Item No.1. Post-facto Approval

Due to COVID-19 pandemic HPC meeting could not be held during the year, 2020. During this period the Chairman had approved 08 proposals for grant of Permanent Recognition. The same was placed before the Committee to ratify the decision of Chairman post-facto. The Committee ratified seven proposals excepting the grant of PR to RCM for reasons specified in the 4th row of **Annexure-B**.

Item No.2. Opening Permission for New College

After going through the proposals, the Committee decided to transfer three proposals relating to B.Sc.(Ag.) and one relating to MPH to A&FE Deptt. and to H&FW Deptt. respectively for necessary action at their end as these courses fall under their domain and they are the appropriate authority to take a call on the proposals. The Committee further decided not to grant opening permission to the rest of the proposals for opening of new Degree/Professional colleges for the academic session 2021-22 as per the decision taken at Part A(iii) in the last HPC meeting held on 11.12.2019, as none of them is a nationally or internationally acclaimed provider of higher education.

The detailed decision in respect of each application is reflected RDE-wise at **Annexure-C**.

Item No.3. Opening Permission for New course (Professional College)/New Stream/ NewHonours Subjects/New Subjects

Basing on the decision taken at Part A (i) and Part A(ii) in the last HPC meeting held on 11.12.2019, the Committee considered only the applications of those institutions for Opening Permission for New course (Professional College)/New Stream/ New Honours Subjects/New Subjects in the existing colleges/institutions from the session 2021-22, who have minimum valid NAAC score of 2.01/NIRF rank within top 200 / 1/3rd of the programs of the college are accredited under NBA or the college/Institution is an autonomous college. These proposals are referred for Joint Inspection by University Authority and Regional Director of Education. Other applications are rejected.

However, applications relating to B.Sc.(Ag.) and MPH will be transferred to A&FE Deptt. and to H&FW Deptt. respectively for necessary action at their end.

The detailed decision in respect of each application is reflected at Annexure-D/1 (Opening Permission for New course (Professional College), D/2 (New Stream), D/3 (New Honours Subjects) & D/4 (New Subjects).

Item No.4. Increase of Seats

Basing on the decision taken at Part A (i) and Part A(ii) in the last HPC meeting held on 11.12.2019, the Committee considered only the applications for increase stream strength and increase of Seats (Professional College) in the existing colleges/institutions from the session 2021-22, having minimum NAAC score of 2.01/NIRF rank within top 200 / 1/3rd of the programs of the college are accredited under NBA or the college/Institution is an autonomous college and referred for Joint Inspection by University Authority and Regional Director of Education. Other applications are rejected.

The detailed decision in respect of each application is reflected at Annexure-E/1 (Increase stream strength) & E/2- increase of Seats (Professional College).

Item No.5. Permanent Recognition

- i. The Committee decided to refer, all the fresh 224 applications received for grant of Permanent Recognition during the last application session, i.e., 1st October 2020 and 30th November 2020 from the existing Non-Government Colleges, for Joint Inspection by the University Authority and respective Regional Director of Education. Final decision on the proposals will be taken after receipt of the Joint Inspection.
- ii. The HPC ratified the orders earlier issued by this Department, during the period when the HPC could not meet due to COVID-19 pandemic, granting Permanent Recognition to the Colleges after due verification at **Annexure-F**.
- iii. It was decided to defer the decision on the 83 proposals for Permanent Recognition received from RDE, Sambalpur, and RDE, Balasore to the next date due to paucity of time.

Item No.6 Withdrawal of Recognition/closure of stream/closure of the college

The Committee took suitable decision on the proposals received from Prescribed Authorities for withdrawal of recognition/closure of stream/closure of college as detailed at **Annexure-G**.

Item No.7. Miscellaneous Matters

It was decided to defer the decision on the proposal received from RDE, Balasore vide letter No. 1457, dated 31.03.2021 for Change of name of Keonjhar Degree Commerce College, New Colony, Dist-Keonjhar to CTG Degree College, New Colony, Dist-Keonjhar till receipt of a fresh report from RDE, Balasore with proper justification.

Item No.8.Other matters

The issue regarding Universities allowing students of a college to appear in the University examination even though the said college has no valid TR/PR was discussed and it was decided to take a decision on the matter by reforming the existing system of grant of PR/TR after consultation with Prescribed Authorities and University Authorities.
