In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules to amend the Odisha Government College Librarians (Method of Recruitment and Conditions of Service) Rules, 2017, namely:-

1. Short title and Commencement –

- 1. These rules may be called the Odisha Government College Librarians (Method of recruitment and Conditions of service) Amendment Rules, 2020.
- 2. They shall come into force on the date of their publication in the Odisha Gazette.

- 2. In the Odisha Government College Librarians (Method of recruitment and Conditions of Service) Rules, 2017 (hereinafter referred to as the said rules), in rule 2,

i. For clause (a) , the following clause shall be substituted namely:-

“(a) “**Commission**” means the Odisha Staff Selection Commission”.

ii. Clause (f) shall be omitted.

- 3. In the said rules, in rules-3, after the words “Assistant Librarian” and before the word “and”, the comma and the word, “Librarian” shall be inserted.

- 4. In the said rules, in rules-4, in clause (b), after the words “ Assistant Librarian” and before the word “and”, the comma and the word , “ Librarian” shall be inserted.

- 5. In the said rules, in rule 6. ---



i. In sub-rule (2), for the words and expression “ Odisha Staff Selection Commission (OSSC)”, the word “Commission” shall be substituted.

ii. In sub-rule (3), for the abbreviation “OSSC” the “Commission” shall be substituted.

6. In the said rules, in rule 8, for the abbreviation “OSSC” the word “Commission” shall be substituted.

7. In the said rules, in rule 10, in sub-rule (1), after the words “Assistant Librarian” and before the word “and”, the comma and the word “, Librarian ” shall be inserted.

8. In the said rules, in rule -11, for sub-rule (2), the following sub-rule shall be substituted, namely:-

"(2) In order to be eligible for the post of Librarian, an Assistant Librarian must have completed a minimum period of 9 (Nine) years of continuous service in the rank of Assistant Librarian.

(3) In order to be eligible for the post of Senior Librarian, a Librarian must have completed a minimum of period of 6 (Six) years of continuous service in the rank of Librarian."

9. In the said rules, rule 13 shall be omitted.

10. In the said rules, for rule 14, the following rules shall be substituted namely:-

"14. Select list in case of Promotion - (1) The recommendation of the Committee under sub-rule (2) of rule 10 shall, after being approved by the Director, from the select list.

(2) The list referred to in sub-rule (1) shall ordinarily be in force for a period of one year from the date of its approval or until another select list is prepared afresh whichever is earlier.

(3) Appointment to any post in the service shall be in the order in which their names appear in the select list."


