RESOLUTION

The 16th July 1983

Sub:—Qualification for recruitment of Lecturers in affiliated Colleges of the State of Orissa.

After careful consideration of the recommendation of the University Grants Commission communicated in their D. O. letter No. F. 1-93/74 (C. P.), dated the 24th August, 1982, addressed to the Vice-Chancellor of Utkal University and that of Government of India, Ministry of education and culture (Department of Education) in their letter No. F-I-12/80-U. L. M. dated the 4th November, 1982, on the above subject, State Government have been pleased to prescribe the following qualifications for recruitment of lecturers of affiliated Colleges:—

- (a) Candidate should have an M. Phil. degree, or a recognised degree beyond Master's level with atleast a second class Master's degree; or
- (b) A candidate not holding an M. Phil. degree should possess a high second class Master's degree i.e. 54% of marks and a second class Honour/Pass in the B. A./ B. Sc./ B. Com. examination; or
- (c) A candidate not holding an M. Phil. degree but possessing a second class Master's degree should have obtained a first class in the Honours/pass in the B. A./ B. Sc. B. Com. examination.

Note—(1) In case candidates having the qualifications as at (a) above are not available, candidates having qualifications as at (b) can be recruited. Similarly, if candidates having the qualifications as at (b) are not available, candidates having qualifications as at (c) can be taken as lecturers.

Note—(2) Candidates who will be recruited to the post of Lecturers of affiliated Colleges having the qualifications as at (a) above will be allowed the university Grants Commissions scale of Rs.700—1,600 whereas candidates recruited as Lecturers having qualifications as at (b) and (c) above, will be allowed the scale of Rs. 525—1,300. These scale of pay are liable to be changed from time to time as and when State Government decide for the same.

2. This shall be treated to have come into effect from the 29th April 1983 in supersession of previous qualifications prescribed in Resolution No. 30910-11 E Y A-3578—E. Y. S. dated the 5th September 1978.

ORDER—Ordered that this Resolution be published in the Orissa Gazette and copy forwarded to all Departments of Government, All heads, of Department/ Accountant General, Orissa/ Secretary to Government of India, Ministry of Education and Culture (Department of Education); Secretary, University Grants Commission/ Principal of all Government and non-Government Colleges/Secretary, State Selection Board/ Secretary, Council of Higher Secondary Education/ Secretary, Orissa Public Service Commission, Cuttack/ Registrars of all Universities of the State.

RESOLUTION

SUMMER—Principles for selection of Head Pandits for non-Government Primary Schools and Constitution of Educational Districtwise Cadres for Primary school teachers and allowing revised scales of pay.

The Pay Rationalisation Committee recommended two scales of pay, i. e., Rs. 300—470 and Rs. 320—550 for Head Pandits of the Primary Schools. There are no sanctioned posts of Head Pandits for the Primary schools. Only the seniormost teachers are designated as Head Pandits. There is also no organised cadre for the primary school teachers. The selection of Head Pandits is now being made on merit, qualification and seniority basis. A number of anomalies are noticed in selection of Head Pandits by the field officers.

2. The matter regarding principles for selection of Head Pandits for non-Government Primary schools and constitution of Districtwise cadres for primary school teachers as well as allowing their revised scales of pay under the Pay Rules 1981 was under consideration of Government. In supersession of all previous orders Government have been pleased to decide that the following principles should be adopted for formation of Districtwise cadre of primary school teachers, procedure for selection, etc. of Head Pandits and allowing their revised scales of pay.
