CORRIGENDUM



No. HE-FE-II(A)-POL-0001/2016 10/49 /HE. In partial modification of Higher Education Department Notification No. 12493/HE dtd. 24.05.2016 the sub clause (ii) of Clause-2 is hereby substituted as follows:


“All the teaching staff appointed under Orissa Education Service in State’s Scale of Pay (Method of Recruitment and Conditions of Service) Rules, 2009 and Orissa Education Service (College Branch) Rules, 1990, presently working in Govt. Jr. Colleges shall be deemed to be on deployment to School & Mass Education Department for a period of one year initially. Simultaneously School & Mass education Department shall create equal number of PGT posts against the current sanctioned strength of 1,023 Junior Lecturers and take steps for their recruitment within a year. Upon the joining of new recruits after due recruitment process, the Junior/Degree Lecturers working on deployment to School & Mass Education Department shall get reverted to Higher Education Department to work against the existing vacancies in Degree Colleges.”


All other conditions as mentioned in the above Department Notification No. 12493/HE dtd. 24.05.2016 remains unaltered.


