ORDER

Government have been pleased to substitute para-3 of the revised guidelines issued in this Department office order No. 24531/HE dated 28.08.2018 for " Vyasakabi Fakir Mohan Bhasabruti" as under :

"iii. Students after passing 12th standard examination with 60% or above marks in aggregate conducted by CHSE, Odisha and studying in +3 Arts with Odia as Honours subject (1st Year) in Degree Colleges / Autonomous Colleges/State Universities of Odisha or other states will be eligible for applying for this Bhasabruti.

Students after passing +3 in Odia (Honours) examination with 60% or above marks in Odia Honours subject conducted by State Universities/ Autonomous Colleges of Odisha and studying Post-Graduation in Odia in any of the State Universities/ Degree Colleges / Autonomous Colleges of Odisha or other states will also be eligible for applying for this Bhasabruti."

This is effective from the financial year 2019-20.

All other conditions of the guideline dated 28.08.2018 remain unchanged.
