No.HE-FE-IV(A)-POL-0026/2016 20335 /HE., In exercise of the powers conferred by sub-section (4) of Section 7-C of the Odisha Education Act, 1969 (Odisha Act 15 of 1969), the State Government do hereby make the following order further to amend the Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid Order, 2009, namely:-

- (1) This order may be called the Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid (Amendment) Order, 2016.
 - It shall be deemed to have come into force with effect from the 1st June, 2016.

2. In the Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid Order, 2009, in para 5, after sub-para (1), the following sub-para shall be inserted, namely:-

" (1-a) The teaching and non-teaching employees of Non-Government Aided Colleges who are in receipt of grant-in-aid in the shape of Block Grant under sub-para(1) shall also receive enhanced block grant with effect from 01.06.2016 at the rate of 25% of their emoluments as on 31.05.2016 and an annual increment of 3% on such enhanced emoluments for each completed year of service, the first such increment shall be effective from 01.06.2017 ".
