Sub: <u>Taking over of B.Ed. Colleges (Teachers' Education Institutions) of SME Department and SSDMBW Department by HE Department with effect from 01.06.2021</u>

As per the above-referred notifications, Higher Education (HE) Department will take over the existing B.Ed. Colleges (Teacher's Education Institutions) of School and Mass Education (SME) Department and ST & SC Development, Minorities and Backward Classes Welfare (SSDMBW) Department w.e.f. 01.06.2021. For smooth transition of the taking over process, the following decisions are hereby taken.

- 1. A dedicated Teachers' Education Section (abbreviated as TE Section) shall start functioning in Campus-I of HE Department (located in Lokseva Bhawan), with effect from 01.06.2021, to deal with all matters pertaining to B.Ed. Colleges (Teachers' Training Institutions) which will be taken over by the HE Department w.e.f. 01.06.2021.
- 2. Dr. Snigdha Mishra, Reader in Education belonging to OES (College Branch) cadre of HE Department but deputed to SME Department and currently posted as Principal (I/C) of PMIASE (Sambalpur), is hereby deployed to HE Department with effect from 01.06.2021 to work as Dy. Director in the newly created TE Section of the HE Department in addition to her own duty as Principal (I/C) of PMIASE (Sambalpur). She will report to the Secretary of HE Department.
- 3. Dr. Sarada Mishra, Reader in Education belonging to OES (College Branch) cadre of HE Department but deputed to SME Department and currently posted

as Principal (I/C) of CTE (Rourkela), is hereby deployed to HE Department with effect from 01.06.2021 to work as Assistant Director in the newly created TE Section of HE Department in addition to her own duty as Principal (I/C) of CTE (Rourkela). She will report to the Secretary of HE Department.

- 4. The dealing assistant of Directorate of TE & SCERT, currently handling the Training College Establishment subject in the said Directorate, will be deployed to HE Department by the Director (TE & SCERT) with effect from 01.06.2021 to work in the newly created TE Section of HE Department under the administrative and functional control of Dr. Snigdha Mishra and Dr. Sarada Mishra.
- 5. The government employees mentioned at Para-2, 3 and 4 above will continue to draw their salary and other remuneration from PMIASE (Sambalpur), CTE (Rourkela) and Directorate of TE & SCERT respectively till further order.
- 6. All files, records and other official documents of Directorate of TE & SCERT pertaining to teachers' education subject (i.e B.Ed. College matters) shall be physically handed over to the newly created TE Section of HE Department by 01.06.2021.
- 7. Similarly, SSDMBW Department is requested to hand over all files, records and other official documents of the Department pertaining to teachers' education subject (i.e. B.Ed. College matters) to the TE Section of HE Department by 01.06.2021.
