PROCEEDING OF THE MEETING OF HIGH POWER COMMITTEE CONSTITUTED VIDE GOVERNMENT NOTIFICATION NO. 15641/HE DATED 01.05.2004 HELD ON 05.04.2007 AT 3.00 P.M. IN THE OFFICE CHAMBER OF COMMISSIONER-CUMSECRETARY TO GOVERNMENT, DEPARTMENT OF HIGHER EDUCATION

1. A meeting of the High Power Committee constituted vide Government Notification No.15641/HE dated 01.05.2004 was held in the Office Chamber of Commissioner-cum-Secretary to consider the proposals for grant of permission/recognition under Section-5 and 6 of the Orissa Education Act, 1969. The list of members present in the meeting is given below:-

The Commissioner-cum-Secretary to Government, Department of Higher Education and the Chairman of the Committee initiating the discussion intimated that 15 proposals from Regional Directors of Education and Director, Higher Education relating to permission/recognition in favour of general and professional colleges have been received in the Department. It was decided to consider on priority the recognition cases of degree/professional colleges for which the students are to appear the ensuing University examination. After detailed discussion the following decisions are taken.

<u>Opening of New Colleges:</u>

Only 03 proposals in respect of +2 colleges were received for permission to open new colleges recommended by the Regional Directors of Education. After taking into consideration the educational need etc. permission is given to two colleges and the proposal of one college was rejected.

It was decided that we should not allow temporary operation of colleges (+2)/(+3) /Professional in residential areas. The DHE and RDEs were advised to check this. During discussion it was also apprehended that a college may function in a temporary accommodation for 7 years and then close operation. It was therefore felt that RDEs and DHE should check the place where the college is proposing to start operation. Further RDE and DHE shall follow the stipulations strictly imposed in the HPC meeting held on 28.03.2007.

The list of colleges allowed/rejected is placed at <u>Annexure-A</u>. This permission is granted subject to condition that the educational agency shall pledge an amount of Rs. 5.00 lakh before the prescribed authority and further amount of Rs. 20..00 lakh shall be deposited in shape of Bank deposit within a period of one month from the date of grant of permission, failing which the educational agency shall not be permitted to admit students. This condition cannot be relaxed by DHE and RDEs under any circumstances. Further Secretary of the Governing Body should furnish an undertaking in the form of an affidavit that they will not claim any financial assistance or grant-in-aid from Govt. in future.

<u>3.</u> <u>Permanent Recognition to +3 Colleges:</u>

Only three proposals in respect of +3 colleges were received from Regional Director of Education, Bhubaneswar to review the proposals of permanent recognition, which were rejected in the HPC meeting held on 31.01.2007 on the ground that Governing Body was not constituted by the college authority. These cases were reviewed by the HPC under Section 6(10) of O.E Act, 1969. After detailed examination and discussion made in this regard, the Committee decided to allow one case and other two cases were deferred with instruction to RDE, Bhubanswar to inspect and submit complete information relating to land particulars, status of Governing Body etc. to the committee for consideration. The list of cases allowed / deferred is placed at Annexure-B.

4. <u>Increase of Seats</u>:

The proposal for increase of seats in one (+2) college and three (+3) colleges have been received from RDEs for consideration. After detailed discussion the committee decided to accord permission to all cases. The list of cases allowed is placed at **Annexure-C**.

<u>5.</u> <u>Opening of New Stream</u>:

Only one proposal for opening of new stream received from Regional Director of Education, Berhampur was taken up for consideration. The Committee decided to allow to open +3 Arts (Hist., Pol. Science, Education and Economics with 64 seats from the session 2007-08) in favour of Saheed Laxman Naik Mahavidyalaya, Baipariguda, Dist. Koraput. subject to condition that:—

- a) +3 Arts wing will given a different name from that of +2 college.
- b) Separate G.B. of this Degree College be constituted as per "The Orissa Education (Establishment, Recognition and Management of Private Colleges) Rules, 1991.

6. Professional Colleges:

Altogether 05 proposals were received from Director, Higher Education in respect of Private Professional Institutions out of which one proposal is relating to grant of permission and 04 proposals are relating to grant of temporary recognition. The Committee after detailed discussion decided to allow one case of opening permission and two cases of temporary recognition. Rest 02 cases of temporary recognition were deferred by the Committee. The list of cases allowed/deferred is placed at <u>Annexure-D</u>.

It was decided that we should not allow temporary operation of colleges (+2)/(+3)/Professional in residential areas. The DHE and RDEs were advised to check this. During discussion it was also apprehended that a college may function in a temporary accommodation for 7 years and then close operation. It was therefore felt that RDEs and DHE should check the place where the college is proposing to start operation . Further RDE and DHE shall follow the stipulation strictly imposed in the HPC meeting held on 28.03.2007.\

The decision of HPC meeting held on 22.02.2007 for granting permission to open MSc. in Anatomy, MSc in Microbiology, MSc in Physiology and Msc. in Bio-Chemistry with 60 seats each from the session 2007-08 in favour of Hi-Tech Medical College and Hospital, Pandra, Bhubaneswar was modified and permission was given subject to approval of the syllabus of these new subjects by the concerned University/ Professional Council. Similarly the decision of the HPC meeting held on 28.03.2007 for granting of permission to open BSc. ITM in favour of Kusagra Institute of Information and Management Science, Pira Bazar, Cuttack was modified and permission was given subject to approval of the syllabus of new subject by the concerned University/ Professional Council. Similarly, opening permission for P.G courses in Aviation Management with 60 seats was allowed in favour of ASBM School of

Aviation Management by HPC in its meeting dated 22.02.2007. The College should be advised to admit students only after approval of the syllabus of the new subject by the concerned University / Professional Council .Director . HE should inform the colleges accordingly .

7. General:

It was decided that grant of recognition to Sanskrit colleges and urgent cases will be taken up for consideration in the next HPC meeting as the students are to appear in the ensuing examination. Hence the RDEs are instructed to submit complete proposals indicating land , building and status of G.B. etc. in the prescribed format to facilitate the discussion.
