CORRIGENDUM

Subject: Revised Interest Subvention Scheme "Kalinga Sikhya Sathi Yojana" on education loan availed by students of Odisha pursuing higher studies.

1. The expression at para 3 of the Resolution No 22869/HE, dated 10.08.2016 relating to period of implementation,

"This Resolution shall come into effect from the financial year 2015-16. That means students, who have availed fresh bank loan on or after 01.04.2015 under Government of India scheme are only eligible for such benefit. Loans paid prior to 2015-16 shall not be covered under the scheme."

shall be substituted by

"This Resolution shall come into effect from the financial year 2016-17. Such students, who have availed fresh bank loans on or after 01.04.2016 under the Government of India scheme shall only be eligible for such benefit. Loans disbursed by banks prior to 01.04.2016 shall not be covered under the scheme."

2. In **partial modification of the para 6** of the Resolution relating to interest subsidy, following **sub para 6 (i) shall be added** below the main para;

"6 (i) The interest subsidy during the moratorium period in respect of students with annual parental income exceeding ~~Rs~~ 4.50 lakh but less than ~~Rs~~ 6.00 lakh, those who have not been covered under Government of India scheme, shall be borne by the Government of Odisha."

3. The **para 7** relating to *Miscellaneous* ..

"The earlier Resolution No 25271/HE, dated 17.11.2015 issued to this effect is partially superseded accordingly. It is further stipulated that the girl

students as well as boy students who were already covered as per the terms of the said Resolution will stand migrated to the new scheme”

shall stand deleted.

This corrigendum shall come into force with immediate effect. All other provisions as in the Resolution shall remain unchanged.

ORDER :Ordered that the Corrigendum be published in an extra ordinary issue of Odisha Gazette for general information of public. Ordered also that copy of the corrigendum be forwarded to all Departments of the Government/ All Heads of the Department/ All Collectors/ Registrar, Odisha High Court.




