





Madam/ Sir,


I am directed to say that a sum of Rs. 18,45,00,000/- ( Rupees Eighteen Crore forty five Lakhs ) Only has been allotted to different Non-Government Aided Degree Colleges in two phases vide Government sanction orders under reference as Infrastructure Development Assistance during the Financial Year 2019-20 . The funds so provided are to be utilized as per the following guidelines.

**The Infrastructural Development Assistance shall be utilized:-**

- For construction as well as extension of existing structure.
- For repair and renovation of the existing damaged infrastructure.
- For construction of toilet, classroom, common rooms for students and teachers, library and laboratory .
- For making provision for power supply and water supply.
- For development of college play ground and boundary wall.

It is made clear that all sorts of development works out of this fund shall be executed through the local executing agencies like PWD, RD, Municipality, Block etc by following prescribed guidelines. The College authorities shall ensure the quality of the project works and timely completion of the project. The utilization Certificate is to be furnished by 31.12.2020, failing which the grant amount shall be recovered from the college and the college shall not be considered for any grant in future .
