Madam/Sir,

I am directed to say that a sum of Rs. 9,99,99,400/- (Nine Crore Ninety-nine Lakhs Ninety-nine thousand four hundred) only has been allotted to different Non-Government Aided Degree Colleges vide Government sanction order under reference for improvement of laboratory facilities of both Science and Humanities during the Financial year 2019-20. The funds so provided are to be utilized as per the following guideline.

Guidelines for utilization of funds for improvement of laboratory facilities

Laboratory Development Fund is to be utilized

1. For purchasing new laboratory equipment, chemicals, glassware, specimen, plant materials, learning models, charts and maps etc.
2. For laboratory infrastructure development like repair or renovation of hardtop on the table, cupboards, racks, laboratory furniture, water connection, gas connections to the laboratories etc.
3. For Repair/ Annual Maintenance Contract (AMC) of the existing machines/ equipment.
4. The college shall follow the approved guideline for procurement/ infrastructure work as applicable to the college. Utilization Certificate is to be furnished by 30.09.2020, failing which the grant amount shall be recovered from the college and they shall not be considered for any grant in future
