RESOLUTION

Bhubaneswar dated the 20th day of March, 2008

No. VI-HE-SC-79/07 11491 /HE. The State Government in their Resolution No.65312 dt.31.12.99, have prescribed the guidelines to regulate the revision of pay scales, minimum qualifications for the appointment of teachers in the Universities and Colleges and other measures for maintenance of standards of Govt. and Non-Govt. aided Colleges. Government is now pleased to make the following amendments to the said Resolution as hereunder:-

1. This Resolution shall be deemed to have come into force on the date of its publication in the Orissa Gazette.
2. Sub-para 4.9.0, 4.9.1, 4.9.2 and 4.9.3 of paragraph 4 of the said resolution shall be omitted.
3. Placement of teachers of Government Colleges under Career Advancement Scheme is to be governed as per Rule 8 and 9 of Orissa Education Service (College Branch) Recruitment Rules, 1990 as amended from time to time. The placement of teachers of Non-Govt. Aided Colleges under Career Advancement Scheme is to be governed as per Govt. Resolution No.9491, dt.19.03.90, Resolution No.3316, dt.22.01.94 and Orissa Education (Amendment) Act, 1998.
4. The present Resolution is equally made applicable to all fulltime teachers working in all the Universities, all the Govt. and Non-Govt. aided Colleges of the State who are in receipt of the U.G.C. scale of pay as on 01.01.96 not withstanding anything contained and done as per the said Resolution in force in the subject.

Order:- Ordered that this Resolution be published in the Orissa Gazette and copy forwarded to all Department of Government/Accountant General (A&E), Orissa/Secretary to Govt. of India, Ministry of Human Resource Development (Department of Education), New Delhi/Secretary, U.G.C., Bahadur Shah Zafar Marg, New Delhi/Principals of all Government and Non-Govt. Aided Colleges/Registrars of all Universities in the State.
