01.05.2004 HELD ON 09.02.2010 AT 11.00 A.M. IN THE OFFICE CHAMBER OF
COMMISSIONER-CUM-SECRETARY TO GOVERNMENT, DEPARTMENT
OF HIGHER EDUCATION**

1. The meeting of the High Power Committee constituted vide Government Notification No.1564/HE dated 01.05.2004 was held under the Chairmanship of Commissioner-cum-Secretary, Department of Higher Education in his office chamber to consider the proposals for grant of permission/recognition in respect of general/professional colleges under Section-5 and 6 of the Orissa Education Act, 1969. The Special Secretary to Government in Higher Education Department attended this Committee meeting as a Special invitee as per the desire of the Chairman.

The Commissioner-cum-Secretary to Government, Department of Higher Education and the Chairperson of the Committee while initiating discussion indicated that altogether 140 proposals for grant of temporary/permanent recognition in respect of

General and Professional Colleges were placed before the committee for consideration. After detailed discussion following decisions were taken.

Grant of Temporary Recognition to +2/+3 Colleges:

The Department had received 15 proposals for grant of Temporary recognition to +2/+3 Colleges. After detailed discussion the committee allowed 12 cases, 02 cases were deferred and 01 case was rejected. The list of cases allowed/deferred/rejected is placed at Annexure-A.

Grant of Temporary Recognition for Increase of Seats in +2/+3 Colleges:

All together 44 proposals for grant of temporary recognition to increase of seats in +2/+3 colleges were received from RDEs. After detailed discussion the committee allowed 41 cases and 03 proposals were deferred. The list of cases allowed/deferred is placed at Annexure-B.

Temporary Recognition for Honours Subjects in +3 Colleges:

All together 41 proposals for grant of temporary recognition to Honours subjects in +3 colleges were received from RDEs for consideration. After detailed discussion the committee allowed 40 cases and 1 proposal was deferred. The list of cases allowed/deferred is placed at Annexure-C.

Grant of Temporary/Permanent Recognition to Professional Colleges:

All together 22 proposals were received from Director, Higher Education for grant of temporary/permanent recognition to Professional Colleges. After detailed discussion the committee allowed 18 cases, 2 cases were deferred and rest 2 cases were rejected. The list of cases allowed/deferred/rejected is placed at Annexure-D.

Grant of Temporary/Permanent Recognition to Sanskrit Colleges:

All together 18 proposals for grant of temporary/permanent recognition to Sanskrit Colleges were received from Regional Director of Education, Bhubaneswar for consideration. After detailed discussion the committee allowed 17 cases and one proposal was rejected. The list of cases allowed/rejected is placed at Annexure-E.

Due to shortage of time the proposals relating to grant of temporary recognition to new subjects and grant of temporary recognition to new stream were deferred to the next HPC meeting.

The Hon'ble High Court vide order dt.24.11.09 passed in W.P.(C) No.111108/08 have directed to OP No.2 (RDE, Bhubaneswar) to grant TR for the session 2007-08 & allow the agency to complete the construction of building by 2014. As 2014 is 11th year after grant of Temporary Recognition the same is against the provision of Section-6(9) of Orissa Education Act, 1969 read with Orissa Education (Amendment) Act, 2000.

Pursuant to the orders of Hon'ble High Court dated 24.11.2009, TR is granted for the year 2007-08 and the EA is advised to transfer the required land in favour of the educational institution within two months from the receipt of this order and complete all infrastructure during 2010-11 as seven years is being completed by this year as per the provision under Section-6 (9) of O.E. Act, 1969. The EA is to apply for TR for the session 2008-09 afresh.

The committee authorised the PA to file a review petition for modification of order dated 24.11.09 of the Hon'ble High Court with respect to completion year in consonance with provisions of Orissa Education Act, 1969 read with Orissa Education (Amendment) Act, 2000.

The Hon'ble High Court vide order dt.16.12.09 passed in W.P.(C)

No.16895/09 have directed the Dy. Director, Dr. B.N. Dhal (RDE, Bhubaneswar) to

take steps for grant of Permanent Recognition to the petitioner's institution if it

possesses the required extent of land. Pursuant to the above order of Hon'ble High

Court, the Dy. Director (Dr. B. N. Dhal), office of the Regional Director of Education,

Bhubaneswar has reported that only Ac.1.60 of land of Makarba Mouza has been

registered in the name of the Kasturba Gandhi Women's College, Manikadelpur,

Pipli, Punt. Out of which Ac.1.60 dec. of land is situated in mouza Makarba bearing

Khata No.27, Plot No.214 under Pipli Tahasil which has purchased on 25.02.2009.

The college in question being a junior college needs minimum Ac.5.00 of land duly

registered in the name of the institution for grant of permanent recognition. The land

should be procured, building should be constructed within seven years of granting of

opening permission as per the provision of Section-6 (9) of Orissa Education Act,

1969. The said college has got opening permission in the year 1992-93.

Further the EA has not admitted fresh students for consecutive two years i.e.

2003-04 and 2004-05 and again from the session 2006 onwards till now. As per the

provision of Section-6 (B) (1) (j) of Orissa Education Act, 1969 if the EA does not

admit fresh students for two consecutive years, recognition can be withdrawn.

In view of the above, since the college does not possess the required extent

of Ac.5.00 of contiguous patch of land in its name, proposal for grant of permanent

recognition is rejected.
