







The LPC/Service Book/CCRs of the concerned officers shall be sent to new station of posting immediately under intimation to this Department. No leave shall be entertained in favour of the lecturers under orders of transfer till their joining in the new place of posting.

As per Rule-9 of OAEIECC and IT Rules, 1979 the Principal in charge is the competent authority to relieve or accept the joining reports of employees under orders of transfer. So, Principal I/C of the concerned colleges are requested to relieve or accept joining report of Lecturers UOT immediately under intimation to the undersigned, failing which administrative action as per sub-rule (xi) of rule-7D of OE Act, 1969 shall be initiated against the Principal concerned for non-compliance of above mentioned instructions.

In the event of transfer of Principal I/C, he/she has to handover charges to his/her next senior most Lecturer of the College.

The Principals are requested to serve copy of the transfer order to the person concerned immediately.




