




Copy forwarded to all the Presidents, Governing Bodies/Principals-cum-Secretaries to Governing Bodies of concerned colleges for information and necessary action. They are requested to relieve the persons concerned under order of transfer and posting with immediate effect and send the relieve/joining reports to this Department forthwith with copies to the concerned Regional Directors of Education. The LPCs/Service Books/CCRs of the concerned officers shall be sent to new stations of posting immediately under intimation to

this Department. No leave shall be entertained in favour of the lecturers under orders of transfer till their joining in the new place of posting.

As per Rule-9 of OAEIECC and IT Rules, 1979 the Principal in charge is the competent authority to relieve or accept the joining report of employee under order of transfer. So, Principal I/C of the concerned colleges are requested to relieve or accept joining report of Lecturers UOT immediately under intimation to the undersigned, failing which administrative action as per sub-rule (xi) of rule-7D of OE Act, 1969 shall be initiated against the Principal concerned for non-compliance of above mentioned instructions.


In the event of transfer of Principal I/C, he/she has to handover charges to his/her next senior most lecturer of the College.


