till their joining in the new place of posting.


As per Rule-9 of OAEIECC and IT Rules, 1979 the Principal in charge is the

transfer. So, Principal I/C of the concerned colleges are requested to relieve or accept joining
report of Lecturers UOT immediately under intimation to the undersigned, failing which
administrative action as per sub-rule (xi) of rule-7D of OE Act, 1969 shall be initiated against
the Principal concerned for non-compliance of above mentioned instructions.

In the event of transfer of Principal I/C, he/she has to handover charges to his/her next
senior most Lecturer of the College.

The Principals are requested to serve copy of the transfer order to the person
concerned immediately.
