College Buildings voted in Budget Estimate for the year 2021-22.
- 3. The work to be completed within the estimated cost in all respect without involving cost and time over run.
- 4. All the codal provisions and procedures laid down under relevant rules is to be strictly followed invariably.
- 5. Technical sanction (T.S.) to be accorded from the competent technical authority before execution of work.
- 6. Work shall be completed as per approved scope of work at the sanctioned cost within the stipulated period of administrative approval. No further, escalation of the estimated cost will generally be allowed without proper justification.
- 7. Physical progress report maintained by PWD will be submitted periodically to Higher Education Department.
- 8. There should not be any change in scheme. Diversion of fund from one scheme to another will not be entertained under any circumstances.
- 9. Previous administrative approval accorded vide this Department order no.11376/HE dt.04.03.2021 is hereby cancelled.
- 10. This has been duly approved by Principal Secretary to Government, Higher Education Department.
