In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules to amend the Odisha Government College Physical Education Teachers (Method of Recruitment and Conditions of Service) Rules, 2019, namely:-

1. (1) These rules may be called the Odisha Government College Physical Education Teachers (Method of Recruitment and Conditions of Service) Amendment Rules, 2021.
(2) They shall come into force on the date of their publication in the Odisha Gazette.
2. In the Odisha Government College Physical Education Teachers (Method of Recruitment and Conditions of Service) Rules, 2019 (hereinafter referred to as the "said rules"), in rule 2, in sub-rule (1), for clause (a), the following clause shall be substituted, namely:--
“(a) '**Board**' means the Selection Board for the State constituted under sub-section (2) of section 10 of the Odisha Education Act, 1969.”
3. In the said rules, in rules 6, for sub-rule (2), the following sub-rule shall be substituted, namely :—
“(2) The competitive examination for the post of Physical Education Teacher shall be conducted by the Selection Board for the State, the date on which and the places at which the examination is to be held shall be fixed by the Board.”
4. In the said rules, the word “Commission”, wherever appears, shall be substituted by the word “**Board**”.
