As per Section 21(3) of the Odisha Universities Act, 1989, Vice Chancellors of the Universities concerned are empowered to issue appointment order in favour of the candidates recommended by OPSC. Though there is no need for approval or ratification by the Syndicate, the Syndicate should be informed of such appointment in its next meeting. **The appointment to be made will be subject to the outcome of W.P.(C) No. 33452 of 2020 (Prof. Kunja Bihari Panda and others - versus - State of Odisha and others) and W.P (C)No.34257 of 2020 (Ajit Kumar Mohanty -versus - State of Odisha and others). This condition must be mentioned in the Appointment Order.**

The applications along with certificates/documents and Attestation Forms, as received from OPSC, in respect of the candidate(s) to be appointed in your university, are hereby forwarded to you for issue of appointment order from your end.


In case of detection of any major discrepancy in his certificates, documents, etc., issue of appointment order should be withheld and the matter should be immediately reported to OPSC under intimation to this Department.
