Notification

In exercise of the powers conferred by sub-section (4) of section 7-C of the Odisha Education Act, 1969 (Odisha Act 15 of 1969) read with clause 20 of the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-aid Order 2008, the State Government do hereby make the following Order for regulating payment of Grant-in-aid to the employees of aided educational institutions being non-Government Colleges, Junior Colleges and Higher Secondary Schools who are eligible under the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-aid Order, 2004 so repealed under the said Order 2008 namely.

1. **Short title, application and commencement:-** (1) This order may be called the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-aid Order, 2022.
(2) It shall apply to the employees of aided educational institutions who are eligible under the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant in Aid Order, 2004 repealed and saved under paragraph 20 of the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-aid Order 2008.
(3) It shall be deemed to have come into force with effect from the 1st February, 2009.
2. **Quantum of Grant-in-Aid:-** The quantum of Grant-in-Aid under this Order for the employees covered under sub-paragraph (2) of paragraph 1 shall be equal to the quantum of Grant-in-Aid applicable to the employees who are governed under the provisions of the Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-aid Order, 2009, as amended from time to time and the provisions of the Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid Order, 2017 including its amendments shall mutatis mutandis apply.
