No. HE-FEIVA-POLICY-0069-2015 /HE., In exercise of the powers conferred by sub-section (4) of Section 7-C of the Odisha Education Act, 1969 (Odisha Act 15 of 1969), the State Government do hereby make the following order further to amend the Odisha (Non-Government Upashastri and Shastri Colleges) Grant-in-Aid Order 2009 namely:

1. This order may be called the Odisha (Non-Government Upashastri and Shastri Colleges) Grant-in-Aid (Amendment) Order, 2022.
2. In the Odisha (Non-Government Upashastri and Shastri Colleges) Grant-in-Aid Order, 2009, in Para 3-

(i) in sub-para (1)

(a) for the words "**on the date of such notification**" appearing at the end, the words "**from February, 2009 which is payable on or after the first day of March, 2009**" shall be substituted.


(b) after the first proviso, the following proviso shall be inserted namely:-

"Provided that any person employed in the teaching and non-teaching post after the 1st June, 2008 shall not be eligible to be covered under this Order".

(ii) for sub-para-4, the following sub-para shall be substituted , namely:

"No claim on account of grant-in-aid under this order shall be made or entertained for any period prior to February, 2009."


