In exercise of the powers conferred by sub-section (4) of Section 7-C of the Odisha Education Act, 1969 (Odisha Act 15 of 1969), the State Government do hereby make the following order to amend the Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid Order 2017, namely:

1. This Order may be called the Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid (Amendment) Order, 2022.
2. In the Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid Order, 2017 (hereinafter referred to as the Order), after Para 3, the following Para shall be inserted, namely:-

**“(3-A) Entitlement with effect from 1<sup>st</sup> January, 2022:-** The employees covered under the Order shall be eligible to receive Grant-in-aid with effect 1<sup>st</sup> January, 2022 as given below.

- (1) The Grant-in-aid so fixed as per clause-3 (1) (a) (b) and (c) of the Order referred above with effect from 1st January, 2018 shall be located in the applicable level in the Pay Matrix attached to a post as per the First Schedule of Odisha Revised Scale of Pay Rules, 2017 (hereinafter the ORSP Rules, 2017). If the grant-in-aid so arrived corresponds to any Cell in the applicable Level of the Pay Matrix, the same shall be the Pay; and if no such Cell is available in the applicable Level, the Pay shall be fixed at the immediate next higher Cell in that applicable Level of the Pay Matrix.


(2) After fixation of Pay in the appropriate Level in the Pay Matrix under sub-para (1) of Para 3-A, the employees shall be allowed annual increments on notional basis in the applicable Level on 1<sup>st</sup> January , 2019; 1st January, 2020; 1st January, 2021 and 1st January, 2022.

(3) The Pay so derived after allowing the notional increments along with Dearness Allowance as admissible as on 1<sup>st</sup> January, 2022 shall be the total emolument which shall be paid to the employees concerned as Grant-in-aid with effect from 1<sup>st</sup> January ,2022.

(4) The employees concerned shall also be eligible to annual increment for each completed year of service with effect from the 1<sup>st</sup> January of every year.


(5) Dearness Allowance as declared by Government from time to time for Non-Government educational institutions shall also be admissible to them. "
