Sub: Guidelines & dateline for PG Vacant Seat Admission (SPOT-II) Selection and Admission under project SAMS for the Academic Session 2021-22

Madam/Sir,

In inviting a reference to the subject cited above, I am directed to inform you that the admission for PG SPOT-II selection and Admission under SMAS will be held as per the guidelines mentioned below:

- 1. Following categories of candidates are eligible to apply:
  - a) Candidates who were previously selected, uploaded the graduation marks & taken admission and/ or previously selected & not taken admission during 1st, 2nd, Spot-I or Spot-I Waiting Selection
  - b) Candidates who have appeared CPET-2021, uploaded the graduation mark but not selected during 1st, 2nd, Spot-I or Spot-I Waiting Selection
- 2. Candidates are advised to go through the University/College wise vacant seat and cut-off mark details at SAMS website before making final selection of option for admission.
- 3. The candidate has to provide only 01 (one) fresh option ((University/College + PG Admission Subject), where s/he wants to take admission. S/he can apply for the subject, in which s/he had appeared the entrance examination (CPET-2021). Earlier entered options will not be considered for PG Vacant Seat Admission (Spot-II). Subject wise eligibility criteria will remain intact as per the Common Prospectus.

- 4. There is no need to deposit the CAF fees. Those, who couldn't pay the CAF fees because of the various reasons will deposit the CAF fees during the time of admission along with the admission fees.
- 5. In PG Vacant Seat Admission (Spot-II), Reservation and Weightage system will not be considered.
- 6. All the seats will be de-reserved & selection will be done on merit (Career Mark + CPET Mark) only.
- 7. The PG Vacant Seat Admission (Spot-II) Merit list will be prepared online in order of merit. (Action: SAMS)
- 8. After publication of the merit list, the selected candidate can pay the admission fees and generate the intimation letter in his/her Student's login. After generation of intimation letter, s/he has to report the allotted institute on the scheduled timeline for admission.
- 9. Those, who have taken admission in earlier phases need to deposit differential amount of admission fees, if selected. For newly selected candidates will have to deposit the full amount as per the admission fees provided by the concerned institutions.
- 10.In case of any mismatch found in marks during admission at the Universities/Colleges, then the candidature will be cancelled and not considered during the current academic session 2021-22.
- 11.Candidate's admission will be updated at selected University/College level as per the previous selection process. (Action: University/College)
- 12.In addition to the merit list, all the remaining candidates will also be placed in the waiting list. In case the candidates do not turn up for admission within the stipulated timeline, Universities/Colleges can publish the selection list out of the waiting list candidates and update in their e-Space like previous Spot-I phase as per the specified timeline. (Action: University/College)
- 13. Candidate, selected from waiting list, has to pay the fees to generate the intimation letter. After generation of intimation letter, s/he has to report the selected institute on the scheduled timeline along with printout of CAF and other certificates, mark sheets from matriculation to degree at the Institution for verification and admission.
- 14. For the candidates, who will take admission in Spot-II PG Vacant Seat Admission, Transfer Certificate will be issued automatically online after successful payment of admission fees.

- 15. All newly admitted candidates shall submit the original CLC.
- 16. In Spot-II PG Vacant Seat Admission, the state wide merit list published earlier will not be taken for consideration.

Once intimation is generated, his/her earlier admission in the previous institute/course will be automatically cancelled.
