I am directed to convey the sanction for abolition of 23 Nos. of teaching posts in the pre-revised scale of pay of Rs. 9300-34,800 with GP of Rs. 4600/- and creation of 23 No. of posts of Assistant Professor (Stage-I) in the Odisha Education Service (College Branch) cadre in Level-10 of the pay matrix of the First Schedule under ORSP (CT) Rules, 2019 (corresponding to pre-revised scale of pay of Rs. 15,600 - 39,100/- with AGP of Rs. 6000/-) in the 03 Nos. of Government Sanskrit Colleges of the State, in different disciplines as mentioned against each college in Annexure-A to this letter. These newly created posts will be governed by the Odisha Education Service (College Branch) Recruitment Rules, 2020.

These posts will carry usual pay and allowances as admissible under relevant Rules of the State Government from time to time. The charge will be debitable to "Demand No. 38-2202-03-University and Higher Education-103-Government Colleges & Institution-0549-Government General Colleges (Voted)" in the budget estimate for the year 2021-22.






