Sub: Transfer of Government College Teachers of Composite Government Colleges from Higher Secondary School Wing to Degree College Wing

1. Though erstwhile +2 Colleges (also known as Junior Colleges) have been separated from Higher Education system and merged with School Education system since 2016, many Government Degree Colleges still house their erstwhile +2 College in their campus, renamed as Higher Secondary School. These Degree Colleges are called 'Composite Colleges' as the Principal of the Degree College also acts as the Principal of the Higher Secondary School.
2. Till School & Mass Education Department recruits teachers for Higher Secondary Schools, Government college teachers of OES (CB) cadre and OES (State Scale of Pay) cadre – Higher Education Department being the cadre controlling authority of both these cadres – are performing the academic activities (such as teaching, examination, evaluation, etc.) pertaining to Higher Secondary School students.
3. In composite colleges, while some teachers have been posted against Degree College wing, some others have been posted against Higher Secondary School wing. As reported by some Principals, this often creates administrative problem in the colleges.
4. Therefore, it has now been decided by the Government that henceforth no OES (CB) cadre or OES (State Scale of Pay) cadre teacher shall be posted against Higher Secondary School wing of any Government composite college. All teachers currently posted in Government composite colleges against Higher Secondary School wings are hereby transferred to the respective Degree College wings w.e.f 01.03.2022 (FN). Since it is a transfer within the same composite college campus, they will be mandatorily relieved from the Higher Secondary School wing on 28.02.2022 (AN) by the Principal of the Higher Secondary School concerned so as to join the respective Degree College wing on 01.03.2022 (FN). They will draw salary from the Degree College wing w.e.f 01.03.2022.
5. Ad-hoc Lecturers and Ad-hoc Junior Lecturers posted in Higher Secondary School wings of composite Government colleges are also hereby transferred to the respective Degree College wings w.e.f 01.03.2022 (F/N). They shall be relieved from the Higher Secondary School wing on 28.02.2022 (A/N) by the Principal concerned so as to join the respective Degree College wing on

01.03.2022 (F/N). They will draw remuneration from the Degree College wing w.e.f 01.03.2022.

6. Sanctioned strength of teachers of all composite Government Colleges, pertaining to OES (CB) and OES (State's Scale of Pay) cadres, hereby stand enhanced to the extent of carrying out this order. However, the total cadre strength of these two cadres will remain unchanged.
7. W.e.f 01.03.2022, all OES (CB) and OES (State's Scale of Pay) cadre teachers, Adhoc Lecturers and Adhoc Junior Lecturers, posted in composite colleges (obviously in Degree College wing) shall be duty-bound to perform teaching and other academic activities pertaining to Degree College wing as well as HS School wing as ordered by the respective Principal or HoD. The Principals and HoDs shall ensure that teaching and other academic activities of HS School wing are not adversely affected by implementation of this order.
8. It is hereby clarified that this order is meant for composite Government colleges only. This order is not applicable to stand-alone Government Higher Secondary Schools, i.e. Higher Secondary Schools having their own independent existence like BJB HS School, Ravenshaw HS School, etc.


