Sub: Appointment of candidates in the vacant posts of Associate Professor on
Re-commendation of OPSC- Regarding

Sir,

State Public Universities under Higher Education Department had submitted their requisition to Odisha Public Service Commission (OPSC) for recruitment to the vacant posts of Associate Professors in their respective Universities. For administrative convenience, the requisitions of the State Public Universities had been consolidated by the HE Department and communicated to OPSC vide HE Department letter No.11485/HE dated 08.03.2021.

In response to the said letter of this Department and after completion of the recruitment process, OPSC has recommended the following candidate vide OPSC letter No. 2616/PSC dated 14.03.2022. (Copy enclosed). Further, the Commission, vide their letter No.9417 dated 22.12.2021, have authorized this Department to allocate Universities to the successful candidates in consideration of their position in the merit list and choice of Universities exercised during application to OPSC.

OPSC has also sent the original application of the candidate along with all relevant documents to this Department vide letter No. 2616/PSC dated 14.03.2022. On the basis of his merit and choice of posting exercised by him at the time of submitting application, the candidate recommended by OPSC is to be appointed in the State Public University as given in the next page.

As per Section 21(3) of the Odisha Universities Act, 1989, Vice Chancellors of the Universities concerned are empowered to issue appointment order in favour of these candidates recommended by OPSC. Though there is no need for approval or ratification by the Syndicate, the Syndicate should be informed of such appointment in its next meeting.

The application along with certificates/documents and Attestation Forms, as received from OPSC, in respect of the candidates to be appointed in your university, are hereby forwarded to you for issue of appointment order from your end.

In case of detection of any major discrepancy in their certificates, documents, etc. issue of appointment order should be withheld and the matter should be immediately reported to OPSC under intimation to this Department.



Annexure-'A'

Basis for Allotment of University (Merit, Choice and Reservation of Posts)


The SC, ST or SEBC candidates selected by OPSC against unreserved vacancies have been adjusted against reserved vacancies, if by this process they get a University of higher choice in order of their preference. This will also be applicable to candidates selected under Woman category. If a PWD category candidate is in the select list, then his/her choice of posting is considered first vis-a vis that of the others.
