## Basis for Allotment of University (Merit, Choice and Reservation of Posts)

The SC, ST or SEBC candidates selected by OPSC against unreserved vacancies have been adjusted against reserved vacancies, if by this process they get a University of higher choice in order of their preference. This will also be applicable to candidates selected under Woman category. If a PWD category candidate is in the select list, then his/her choice of posting is considered first visa vis that of the others.
