
No.HE-FE-IV(A)-POL-0069/2015 9042 /HE., In exercise of the powers conferred by sub-section (4) of Section 7-C of the Odisha Education Act, 1969 (Odisha Act 15 of 1969), the State Government do hereby make the following order further to amend Odisha (Non-Government Upashastri & Shastri Colleges) Grant-in-Aid Order, 2009 namely :-

1. (1) This order may be called the Odisha (Non-Government Upashastri & Shastri Colleges) Grant-in-Aid Order (Amendment) Order, 2016.
(2) It shall apply to the Non-Government Upashastri & Shastri Colleges.
(3) It shall come into force with effect from the 1st day of January, 2014.
2. In the Odisha (Non-Government Upashastri & Shastri Colleges) Grant-in-Aid Order, 2009, in Para-3 (1) of the order, for the words "Not exceeding 40% of the salary at initial level on the date of such notification", the following shall be added; namely:-

"at the rate of initial pay plus Grade Pay with 01 (one) increment in the revised scale of pay of Odisha Revised Scale of Pay Rules, 2008."

Order: Ordered that the Notification shall be published in an extraordinary issue of the Odisha Gazette.


