Madam/Sir,

State Public Universities under Higher Education Department had submitted their requisition to Odisha Public Service Commission (OPSC) for recruitment to the vacant posts of Assistant Professors in their respective Universities. For administrative convenience, the requisitions of the State Public Universities had been consolidated by the HE Department and communicated to OPSC vide HE Department letter No.39101/HE dated 27.11.2020.

In response to the said letter of this Department and after completion of the recruitment process, OPSC has recommended the following candidates vide OPSC letter No. 4617/PSC dated 06.05.2022. (Copy enclosed). Further, the Commission vide their letter No.9417 dated 22.12.2021, have authorized this Department to allocate Universities to the successful candidates in consideration of their position in the merit list and choice of Universities exercised during application to OPSC.

OPSC has also sent the original application of the candidates along with all relevant documents to this Department vide letter No. 4617/PSC dated 17.05.2022. On the basis of their merit and choice of posting exercised by them at the time of submitting application, the candidates recommended by OPSC is to be appointed in the State Public University as given below.



Annexure-'A'**Basis for Allotment of University (Merit, Choice and Reservation of Posts)**

The SC, ST or SEBC candidates selected by OPSC against unreserved vacancies have been adjusted against reserved vacancies, if by this process they get a University of higher choice in order of their preference. This will also be applicable to candidates selected under Woman category. If a PWD category candidate is in the select list, then his/her choice of posting is considered first vis-a vis that of the others.

1) No other SC Candidate did qualify.

2) The Commission herewith authorizes the Department of Higher Education on its behalf to allocate universities among those successful candidates with due regard to their merit in list in conjunction with their choices of universities as exercised.

3) The Commission herewith suggests that,

(i) if a candidate under reserve category has been placed against the UR vacancy on merit, he/she can avail a service or cadre of higher choice of his/her preference had he/she been adjusted either against UR or reserved vacancies. In other words, such candidates have the options of both being under UR category as well as the reserve category so far as availing of his/her higher choice of service or cadre is concerned.

(ii) If a candidate coming under horizontal reservation (e.g., Women, Ex-Serviceman, PWD, Sportsperson) has secured a position in the merit list, he/she can avail a service or cadre of higher choice of his/her preference by virtue of the position in the merit list under the parent vertical category irrespective of the horizontal category he/she represents.

4) The Commission further desires that this said allocation to be authenticated by an officer not below the rank of Additional Secretary of the Deptt. and hoisted in department's website for general information
