In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules to amend the Odisha Revised Scales of Pay (College Teachers) Rules, 2019, namely:-

1. (1) These Rules may be called the Odisha Revised Scales of Pay (College Teachers) (Amendment) Rules, 2022.

(2) They shall be deemed to have come into force from the day the Odisha Revised Scales of Pay (College Teachers) Rules, 2019 came in to force.

2. In the Odisha Revised Scales of Pay (College Teachers) Rules, 2019 (hereinafter referred to as the said rules), in rule 7, in sub-rule (1), after clause (ii), the following clause and note shall be inserted, namely:-

"(iii) Readers or Assistant Professors (Stage-III) who have completed 5 years of service as Reader or Assistant Professor (Stage-III) between 01.01.2016 and 17.02.2021 (both days inclusive) are eligible for minimum initial pay of Level-13A (Cell 1: Rs.1,31,100) and will be re-designated as Associate Professors.

Note:

The provision mentioned in clause (iii) above shall cease to operate with effect from 18.02.2021, i.e. the date from which Odisha Education Service (College Branch) Recruitment Rules, 2020 came into being. Readers or Assistant Professors (Stage-III) who have completed or will be completing 5 years of service as Reader or Assistant Professor (Stage-III) on or after 18.02.2021 shall be considered for promotion to Associate Professor rank strictly as per the provisions of the Odisha Education Service (College Branch) Recruitment Rules, 2020 and only after such promotion they shall be eligible to draw pay in Level-13A."
