In inviting a reference to the subject cited above, I am directed to say that as per the information received from the concerned quarters, the draft disposition list of Junior Lecturers has been prepared and circulated now, for a period of 30 days, inviting objections relating to any erroneous entry of personal service data, from the concerned Junior Lecturers.

The concerned authorities are requested to serve a copy of the draft disposition list as soon as possible, for perusal of the Junior Lecturers concerned with dated acknowledgement and to submit his/her objection if any, within next 15 days from the date of acknowledgement.


The Junior Lecturers concerned, suggesting correction of any erroneous entry of personal service data, in the draft Disposition list, may furnish his/her objection with supporting documents to the concerned authority and also furnish a soft copy to the Department via E-mail- [hedsec.od@nic.in](mailto:hedsec.od@nic.in) . The concerned authority will verify the documents and furnish necessary report to the Department in

next 15 days time from the date of receipt of objection, for effecting correction and for publication of the final disposition list of Junior Lecturers.

It is expected that the entire process of finalization of disposition list of Junior Lecturers will be completed in a period of two months from the date of publication of the Draft Disposition List.
