




**PROCEEDINGS OF THE HIGH-POWER COMMITTEE MEETING HELD ON
09.11.2022 AT 5.00 PM UNDER THE CHAIRMANSHIP OF PRINCIPAL
SECRETARY TO GOVERNMENT, HIGHER EDUCATION DEPARTMENT**

A meeting of High-Power Committee was held on 09.11.2022 at 5.00 P.M through virtual mode under the chairmanship of Principal Secretary to Government, Higher Education Department for consideration of the proposals/ Joint Inspection Reports received from the Prescribed Authorities vis-a-vis the applications received from various Educational Agencies/ Non-Government Colleges/ Professional Colleges for grant of permission/ recognition under Section 5 and 6 of Orissa Education Act, 1969.

The list of members attended the meeting through virtual mode is at **Annexure-A.**

At the outset, the Principal Secretary to Government-cum-Chairman of HPC welcomed all the members of the Committee and made his opening remarks that as per the report of All India Survey on Higher Education, the State has 24 colleges per lakh population as against all India average of 30 colleges. Besides, the Gross Enrolment Ratio (GER), in Odisha is 21.7 as against all India average of 27.1. Hence, in order to fulfil the educational needs and aspirations of the students and to enhance the GER, it is imperative to go for opening of new colleges/ streams/ subjects in the State. The Additional Secretary to Government-cum-Convenor briefed the members about the agenda of the meeting. Before going through each proposal, the Committee decided to review the decisions taken earlier in the HPC meeting held on 11.12.2019 with respect to grant of permission for opening of new Colleges/ Streams/ Subjects and Increase of seats/ stream seat strength etc. After threadbare discussions, the following decisions were taken unanimously.

- i. It was decided in the HPC meeting held on 11.12.2019 at point A(iii) of the proceedings not to grant permission for opening of new degree or professional college for a period of five years from the academic session 2020-21 having exception to the nationally and internationally acclaimed Educational Agencies. The committee unanimously decided to withdraw the said decision taken earlier and allow opening of new colleges taking into account the educational needs and aspirations of the locality concerned.
- ii. Besides, it was also decided to accord permission for increase of seats/ opening of new subjects/ stream/ courses (including PG courses) in pursuance of the provision u/s 5 of OE Act, 1969 irrespective of NAAC CGPA score/ NIRF Ranking/ accreditation by NBA for the academic session 2022-23 and onward until further orders.



- iii. Joint Inspection shall be conducted by the Prescribed Authority or representative of the Prescribed Authority and one representative from the concerned University. In the case of non-confirmation by the University Authority or non-availability of University Representative for Joint Inspection within 15 days from the date of issue of intimation/ request made by the Prescribed Authorities, inspection is to be conducted either by the Prescribed Authorities or by the representative of the respective Prescribed Authority in order to avoid delay in inspection and submit report thereof for disposal of the applications.
- iv. It has been observed that the college authority decides to close the college either due to poor enrolment arising out of non-availability of students in the locality or lack of interest of students in the existing courses or due to unavoidable circumstances. The Prescribed Authorities further informed the committee that there are certain colleges that are not running well and the college authority wants to close the college. But the Educational Agencies dare not to close the college due to forfeiture of 50% of pledged money. In such cases, non-closure of the college leads to further deterioration of quality education of the college concerned. Under the aforesaid circumstances, the committee felt that it is not justified to forfeit of 50% of the Pledge Money i.e. 15 lakhs in case of degree college and 10 lakhs in case of professional college. Hence, the committee unanimously decided to place a proposal before the Government to refund 100% Pledge Money to the Educational Agencies in the event of closure of college.
- vi. Many colleges are not applying for affiliation in time even after getting permission and recognition from the Government. The Prescribed Authorities are requested to direct the colleges to apply for affiliation in time while granting recognition.
- vii. The Prescribed Authority to ensure that increase of seats in each subject is mentioned clearly in the Joint Inspection Report/ Inspection Report while recommending for increase of stream seat strength.
- viii. Applications received in this Department through SAMS (HPC) portal for grant of permission during the session 2022-23 (i.e. from 01.10.2022 to 30.11.2022) shall be sent to the concerned Prescribed Authority for Joint Inspection/ Inspection and submission of report for consideration of the HPC in its next meeting.

The High-Power Committee perused the agenda notes and Joint Inspection reports received from the Prescribed Authorities in detail. After discussion and deliberation, the following decisions were taken on the proposals/applications presented before the Committee.

th

1. **Post-facto Approval**

- a. In the HPC meeting held on 05.08.2021, time up to 31.12.2021 was granted to the defaulter Educational Agencies/ Colleges to deposit the 2nd instalment of pledge money. Considering the representation received from different Educational Agencies/ colleges/ Institutions and keeping in view the financial difficulties occurred owing to COVID-19 situation, this timeline was extended up to 31.10.2022 and the decision was communicated vide this Department Letter No.33497/HE, dated 06.08.2022 and Letter No.31476/HE, dated 27.07.2022. The Committee approved the extension of timeline up to 31.10.2022 for deposit of 2nd instalment of pledge money.

In case of non-compliance by the Educational Agency, the recognition shall be withdrawn as per provision under section 6(B) of OE Act, 1969. Show cause notice to be issued by the Prescribed Authority to the colleges failed to deposit the 2nd instalment of pledge money u/s 6-B(2) of OE Act, 1969 before placing the proposal for withdrawal of recognition u/s 6-B(1)(a) and 6-B(1)(b) of the OE Act, 1969 in the HPC meeting for non-fulfilment of conditions of recognition.

- b. The decision taken by the Chairman-cum-Principal Secretary to Government in view of urgency of different proposals and orders issued after 22.04.2022 on these proposals granting opening permission/ Permanent Recognition/ closure of colleges/ withdrawal of admission restriction etc. in favour of various Colleges/institutions were placed before the committee for consideration and ratification. The Committee ratified these proposals as detailed at *Annexure-B*.

2. **Permanent Recognition**

139 proposals/Joint Inspection Reports for grant of Permanent Recognition have been received from all the RDEs with reference to applications submitted during the session 2018-19 to 2021-22.

- i. All the Proposals, as cited under *Annexure-C/1*, for grant of Permanent Recognition are allowed/ partly allowed by the committee.
- ii. The proposals that are not recommended or deferred by the Joint Inspection Team for non-fulfilment of conditions of recognition i.e. permanent recognition are placed at *Annexure-C/2*. These proposals are rejected/ deferred accordingly.

3. **Opening of New stream/ Honours subjects/ course (professional) and Increase of stream seat strength/ strength (professional)**

23 proposals have been received from the Prescribed Authorities (i.e. RDEs) after joint inspection for grant of permission for opening of New Hons. subject, increase stream seat strength etc. The decision of the Committee in respect of each application is reflected at **Annexure-D**.

4. **Closure of College/ Stream/ Subject**


