## **ORDER**

No. PT7-HE-FEIVA-POLICY-0037-2014/ 5598 /HE, Date: 08.02.23

In exercise of the powers conferred by sub-section (4) of Section 7-C of the Odisha Education Act,1969 (Odisha Act 15 of 1969), the State Government do hereby make the following Order to regulate the payment of Grant-in-Aid to Non-Government Aided Educational Institutions being Degree Colleges, Junior Colleges and Higher Secondary Schools, namely—

- **1. Short title and commencement**—(1) This order may be called the Odisha (Payment of Grant-in-Aid to the Non-Government Aided Degree Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid Order, 2023.
- (2) It shall be deemed to have come into force with effect from the First of January, 2022.
- **2. Applicability**—Subject to the provisions of this Order, it shall apply to the employees who are governed under the provisions of the Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid Order, 2017 and are in receipt of 100% GIA salary as on the 31<sup>st</sup> December, 2021 under the said order.
- **3. Entitlement**—(1) The employees covered under the order referred to in Paragraph 2 and are in receipt of 100% Grant-in-Aid as on the  $31^{\text{st}}$  December, 2021, shall subject to such conditions as may be imposed, be eligible to receive the revised Grant-in-Aid in the following manner, namely:-
  - (a) The Grant-in-aid so received after annual increments and admissible Dearness Allowance as on the 31<sup>st</sup> December, 2021 as per clause 3(1)(a), (b) and (c) of the Order referred to in paragraph 2 shall be located in the applicable level in the Pay Matrix attached to a post as per the First Schedule of the Odisha Revised Scale of Pay Rules, 2017 (hereinafter the ORSP Rules, 2017). If the grant-in-aid so arrived at corresponds to any Cell in the applicable Level of the Pay Matrix, the same shall be the Pay; and if no such Cell is available in the applicable Level, the Pay shall be fixed at the immediate next higher Cell in that applicable Level of the Pay Matrix.
  - (b) The Pay so derived along with Dearness Allowance as admissible with effect from the First of January, 2022 shall be the total emolument which shall be paid to the employees concerned as revised Grant-in-aid with effect from the First of January, 2022.
- (2) The employees shall be eligible to annual increment on each completed year of service with effect from the First of January under normal circumstances every year.
- (3) The Dearness Allowance as declared by the Government from time to time for Non-Government educational institutions shall also be payable to them.

4. **Repeal**— The Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid (Amendment) Order, 2022 issued by the notification of the Government of Odisha in the Higher Education Department No. 1396/HE, dated 11.1.2022 and published in the Extra-ordinary issue of the Odisha Gazette No. 113, dated the 11th January, 2022 is hereby repealed.
