They are not entitled to any advance increment for possessing

Ph.D., M.Phil. or any higher qualification. They will be covered by the Contribution Pension Scheme in accordance with the Odisha Civil Services (Pension) Amendment Rules, 2005. They are not entitled to UGC scale of pay.

Ordinarily, there will be no transfer of the newly recruited teachers for three years from their place of posting.

The lecturer concerned shall have to submit following documents at the time of joining.

- 1. Original copies of certificates and mark sheets for verification.
- 2. Attested photocopies of certificates and mark sheets for preservation in personal file.
- 3. Character certificate from two gazetted officers of Government not below the rank of Group-B.
- 4. Medical Certificate in support of physical fitness from CDMO/CMO/ and Medical officer of equivalent rank.
- 5. Undertaking that she/he has only one spouse living, in case she/he is married.

In case the Governing Body fails to issue the appointment order as per above time schedule, action under Rule, 13(1) of the Odisha Education (Selection Board for the State) Rules, 1992 shall be initiated against the Governing Body concerned.
